 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is an L-shaped frame house of two and one half stories, with a gabled roof. On the front facade are three bays under a gable plus a gabled wing projecting toward the street. On the front of this wing is a two story polygonal bay window under another gable. These two gables on the front of the house each have a round arched window and are ornamented by imbricated shingle. Across the three bays opposite the wing is a partially enclosed porch.

STATEMENT OF SIGNIFICANCE

This vernacular style house, probably built in the late 19th century, contributes to the character of Locust Street which possesses many large houses of late 19th and early 20th century construction. Like the neighboring houses on either side, as well as several other Locust Street houses, the basic design is an L-shaped house with a two story bay window on the front wing.


