DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

Monsieur's Folly is one of the larger houses of the neck district. It is located on LeCompte Creek. It is a two and one-half story frame structure, two bays deep, with a two story wing. Both portions of the house are three bays long but the entrance door is in the larger part.

On the first floor are, from west to east, two windows, the door, and then three more windows. On the second floor there are three windows in each part. There is no separation in the facade; the beaded clapboard runs uninterrupted throughout the facade. The front door has sidelights and transom and it probably had a porch originally.

The windows on the first floor have 2/2 sash and paneled shutters. The windows on the second floor have 6/6 sash and paneled shutters. The shutters are of 20th century date. Both sections have a wood shingle roof stained spanish brown. On the larger portion are two dormers with "A" roofs.

The most outstanding feature is the chimney on the west gable. Since the building is two rooms deep, it has fireplaces in each of the first and second story rooms, but unlike the usual arrangement, with two vertical stacks, the two stacks join at the second floor and continue in one stack. This juncture is supported by a large semicircular arch between the two stacks. A comparable chimney exists on the Hallie Seward House.(D-79)

On the gable, flanking the chimney are two 6/6 sash windows. A one story screened porch stretches across the creek side of the larger portion of the house. Behind the lower wing of the house, set at right angles thereto is a 2-story hyphen connected to a one story kitchen. The chimney, which formerly stood on the north gable, has been removed and replaced with a series of windows. On the east side of the kitchen is an enclosed porch and on the east gable of the house is a block pump and furnace house.

The floor plan is like the typical town house, containing a stair hall with two parlors on one side. On the other side is a large dining room. The latter room, from evidence in the foundation and roof, was the original house and probably was a hall and parlor house of eighteenth century date. Behind the dining room is a corridor with stair and laundry room and the kitchen. The majority of the woodwork is original to the period of about 1820-30.

STATEMENT OF SIGNIFICANCE

Architecturally, Monsieur's Folly is one of the most significant farmhouses of the late Federal period. Its chimney is outstanding and probably remains because of the footing which is composed of the vein of stone which runs north - south in the upper part of the county. It is also one of the largest frame buildings of the period in the county. Archeologically, more information can be gathered concerning the construction of the wing, but this would require a more thorough investigation of the building as well as the records.

The property was patented in the 1660's and adjoins the early patented lands of Anthony LeCompte.
