This is a two and one half story frame house with a tall hip roof and center chimney. On the front is a large gabled dormer with a double window ornamented with imbricated shingles. Across the two bay front is a one story porch supported by Doric columns with a ballustrade between the columns. On the north side of the house is a gable with imbricated shingles.




