<p>Indian Range stands on the north end of Bar Neck and is a good early 19th century farmhouse which grew during the 19th and early 20th centuries. Its original portion is the west half and consists of a three bay long, two and one-half story frame part with exterior brick chimney. On the east side is a section of near equal size which is only two bays long, plus a one and one-half story kitchen wing. All of the windows have 2/2 sash except the dormers which have the original 6/6 sash. Across the north is a porch of around 1900.</p> <p>On the farm are several early outbuildings constructed of white pine and oak, including a smoke house, barn, and corn house.</p>
