The Louis L. Smith house is one of a half-dozen early twentieth-century pyramidal roofed houses that face Railroad Avenue east of "Buckland." Lida M. Smith purchased this corner from Sarah C. Fletcher in September of 1903, and it is thought Lida, and her husband Louis L. Smith financed construction of the two-and-a-half story dwelling soon afterwards.

The Louis L. Smith house stands on the north side of Railroad Avenue directly east of the mid eighteenth-century dwelling, "Buckland." The two-and-a-half story frame dwelling faces south.

Built around 1904, the two-and-a-half story frame house is supported by a common bond brick foundation and is sheathed with a uniform layer of aluminum siding. The steeply pitched pyramidal roof is covered with asphalt shingles.

The south (main) facade is an asymmetrical three-bay elevation with an east bay entrance and a flanking two-over-one sash window. The front door is topped by a single-pane transom. Immediately east of the entrance is a diamond-shaped colored glass window. The first floor is completely sheltered by a Tuscan columned porch. A small gable marks the entrance bay, and a handrail stretches between the posts. The second floor is lighted by three unevenly spaced two-over-one sash windows. Louvered aluminum shutters flank the windows. Centered on the south slope of the roof is a large gabled dormer with a three-part Palladian-style window. Rising through the center of the house is a narrow brick chimney.

The east elevation is distinguished by a projecting two-story gabled bay pavilion with two-over-one sash windows on the first and second floor along with an arched single-pane sash attic light.

The west elevation is marked by a projecting two-story, three-sided gabled pavilion with two-over-one sash on each floor and an arched single-pane attic sash window. The front porch wraps around to the west side and provides access to the side entrance. A glazed side door is topped by a single-pane transom.

The north (rear) elevation is an asymmetrical facade as well with a projecting two-story gabled bay and flanking single story shed roofed enclosed porches.

The interior was unseen.

The Louis L. Smith house is a large two-and-a-half story early twentieth-century frame house that stands on the north side of Railroad Avenue in a line of contemporary dwellings. The pyramidal roofed structure is similar to several other nearby houses with a wraparound Tuscan columns porch, colored glass stair windows, and large gabled dormers.

Louis L. Smith is credited with erecting this house around 1904 after the lot of ground facing Railroad Avenue was purchased in September of 1903 by Lida M. Smith.




2½ story, square frame structure covered with aluminum siding. Hip roof covered with asphalt tile. One center inside chimney which appears to have had a Widow's Walk. Rear and side has a 2-story projection. Left side has a 2-story bay.

Front facade is 3 bay; entrance in 3rd. Door has a large single light over horizontal wood panels. There is a transom. There is a diamond-shaped (colored), decorative glass to the right of the entrance. There is a wrap around veranda; a portion is screened. It is supported by Doric columns. A hand rail with extremely narrow pickets (75 pickets in one section) Replaced shutters.

Unusually wide 2 over 1 window in 1st story; there are three 2 over 1 in 2nd story.

Front dormer has a palladian window.

American bond brick foundation.


Double lot of land, Lots #1 and #58 purchased by Lida M. Smith from Sarah C. Fletcher and husband, Sept. 23, 1903 - DLR CL 20/226.

House built by Louis L. Smith between above date and May 18, 1904, when it was assessed. (From the tax records).

CL 20/226 - April 1, 1896. Previous history of the land merges with that of "Buckland" known for a long time as "The Fletcher House."

Trustees for the Major Fletcher estate were his sons, William M. Fletcher and John W. Fletcher. In this deed they conveyed land to the widow, Sarah C. Fletcher, to be sold as building lots. By the time she sold these lots in 1903, she apparently had remarried.
