The Rickwood house, located on the north side of Railroad Avenue, is one of a half-dozen pyramidal roofed, turn of the century dwellings in East New Market. The squarish two-and-a-half story frame structure displays a combination of Victorian and Colonial Revival features, a common stylistic mixture for houses dating to this period. The Colonial Revival columned porch and the Palladian inspired three-part windows are contrasted with spindle decoration and layers of fishscale shingles.

Dorchester land and tax records indicate the house was erected in 1898 after Everett E. and Sallie Holland purchased the Railroad Avenue lot from William M. Fletcher. The frame dwelling is listed in tax records as "new" at the time.

The Rickwood house, also known as the Everett E. Holland house and the Boston property, is a two-and-a-half story, three-bay frame house that stands on the north side of Railroad Avenue in East New Market, Dorchester County, Maryland. The late nineteenth-century frame dwelling faces south.

Reported to date to 1898, the squarish frame dwelling is supported by a stretcher bond brick foundation and sheathed with vinyl siding. The steeply pitched pyramidal roof is covered with asphalt shingles. Piercing the peak of the roof is a narrow brick stack.

The south (main) facade is an asymmetrical three-bay elevation with the entrance located in the east bay. The partially glazed front door is flanked by a diamond-shaped colored glass window to the east, while two-over-one sash windows fill the adjacent bays to the west. The first floor is completely covered by a single-story square post porch that has been screened in. A small off-center, pedimented gable marks the entrance bay, and the pediment tympanum is covered with wooden shingles. The second floor is lighted by three unevenly spaced two-over-one sash windows with plain trim. Stretching across the base of the roof is a plain boxed cornice. Centered south slope of the pyramidal roof is a large gabled dormer with a pediment front and a three-part window. The sides of the dormer are covered with decorative fishscale shingles.

The east elevation is an asymmetrical two-bay facade with a small, colored glass window filling the southeast bay. Otherwise, the first and second floors are lighted by two-over-one sash windows. The east slope of the hip roof is marked by an off-center gabled dormer pierced by a two-over-two attic window.

The west elevation, on the other hand, is an uneven elevation with the north bay set in a few feet from the wall surface. The eave of the recessed north bay is trimmed with spindle and fishscale shingle decoration. The south bay is pierced on both floors by two-over-one sash window. Centered on the west slope of the roof is a pedimented gable dormer finished with fishscale shingles and pierced by a three-part window.

The north side of the house is partially covered by a modern carport.

The interior was unseen.



PROPERTY OF MR. AND MRS. JOHN C. (Jack) RICKWOOD

2½ story, square frame structure covered with aluminum siding. Hip roof (asphalt tile). Center chimney with corbels. Boxed cornices.

Front gabled dormer has triple row of narrow windows 1 over 1 surrounded by decorative diamond shaped wood shingles. All dormers are identical to front.

On left side in rear, half of building is recessed approximately 3 feet. Over this area is decorative wood trim consisting of two rather wide panels.

Right side has two Queen Anne windows.

Front facade is 3 bay; entrance in 3rd. There is a diamond shaped (colored) decorative glass to the right of the entrance. Plain surrounds. Pedimented entrance. Narrow drip board. Windows 2 over 1.

There is a screened veranda. Brick foundation. (Beware of Dog).

A modern massive equipment building to house tractor-trailers.


