DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Saint Marks Lutheran Parsonage is a two and one-half story frame cross gable Carpenter Gothic residence.

The principal facade is three bays wide. The main entrance is a replaced door located in an arched entranceway with a two light transom (painted over) and two light side lights with bottom panels.

Occupying the remaining bays on the first and second levels are 2/2 windows located in arched window openings. A small arched 1/1 window is located in the center gable.

A decorative one story porch with boxed columns, plain railing and pierced and scrolled brackets extends across the front of the building. The foundation of the porch has been enclosed with trellis work.

Extending to the rear of the building is a two story original addition with two story open porch. The entire building is covered by asbestos shingles over the original novelty siding.

The roof is covered by patterned slate with fishscale shingles connected to the building by a plain boxed with dentiled frieze. Two corbeled chimneys extend from the north and south gable ends of the building.

The entire building is constructed on a low random stone foundation. Much of the original corner block moldings remain intact in the house.

Since William Stettlemyer acted as first minister to the congregation, it is most likely that he was the first occupant of the parsonage.


