DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Harry Shankle House is a two and one-half story flank gable brick residence laid in common bond which faces south from the north side of Buckingham Lane in Buckeystown.

The principal facade is seven bays wide. The main entrance, an original four panel door with three light transom, three side lights with bottom panel and colonnades is set into an arched entrance with twin header arches and circular molding in the second bay.

Occupying the remaining bays on the first level are two bayed areas each containing three narrow 1/1 windows with large wood lintels.

An open frame porch with turned columns, dentiled cornice, and decorative trellis work extends across the front of the first level of the building.

Occupying the three bays on the second level are 2/2 windows with louvered shutters. The main block of the building is two bays deep.

An original two story brick addition extends to the rear of the main block on the northeast side. A recent one story frame addition extends to the rear of the main block.

The building is constructed on a low brick foundation and is covered by the original slate roof with boxed cornice with return and frieze.

Harry Shankle was the brother of Steiner Shankle who lived next door (F-1-113) and both ran the Shankle Meat Market in Buckeystown.


