The Buckeystown Packing and Canning Company is a series of three two story buildings set on a diagonal on the north side of Manor Woods Road.

The first building from the west end is a two story vertical board and batten building constructed on a low random stone foundation. The building is six bays long and six narrow bays remaining or three regular bays wide.

The second building is a very plain utilitarian two story brick building laid in common bond which is comparable inside to the vertical board and batten building being six bays deep and approximately three bays wide.

The third building located on the east end of the set of cannery buildings appears to be the oldest of the three. The building, a one and one-half story whitewashed stucco over brick structure, is also the smallest of the three buildings.

The buildings operated as a cannery under the Baker family until the late 1920's. In the 1930's the cannery was operated under George Leicester Thomas, Jr. who sold the business to Henry Koontz of Pennsylvania. In 1948 Randolph Nock purchased the property and until 1953 the buildings were operated as the Buckeystown Canning Company. The canning operations were shut down permanently in 1953 when the property was sold at public auction. Currently the buildings are used for warehousing.

### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Buckeystown Packing and Canning Company is a series of three two story buildings set on a diagonal on the north side of Manor Woods Road.

The first building from the west end is a two story vertical board and batten building constructed on a low random stone foundation. The building is six bays long and six narrow bays remaining or three regular bays wide. Located in the second and fifth bays on the east side of the building on the first level are large twin diagonal plain wood doors.

Occupying each remaining bay on the first and second level on the east and west sides of the building are double hung six over six windows most of which are broken. Several of the frames are in disrepair.

The southend of the building accommodates two entrances. The original entrance, a six panel door with plain recessed panels and one light transom is located in the second bay. An additional door was cut into the side of the building in the third bay and has been covered with plywood.

Double hung 6/6 windows once graced either side of the main entrance and are located in the fifth and sixth bays on the first level. Double hung 6/6 windows are located in each bay on the second level. Except for the added door, the north side of the building is identical to the south side.

The gently sloping front gable slate roof is attached by a plain boxed cornice. Two frame rectangular cupolas with four six pane windows and gable roof grace the north and south center ends of the building. Both cupolas are in disrepair.

The second building is a very plain utilitarian two story brick building laid in common bond which is comparable inside to the vertical board and batten building being six bays deep and approximately three bays wide. There are no openings on the north or south gable ends of the building.

Located on the first level of the east side of the building once were twelve bays which have all been recently bricked closed. Beginning with a double hung 6/6 window the bays alternated between a door and a window opening.

On the second level is located six bays each occupied by double hung 6/6 windows. A bricked in space indicates an opening was once located between the second and third bay.

Six bays each occupied by 6/6 windows are located on each level of the west side of the building. The entire structure is built on a low whitewashed coursed stone foundation and is covered by a gently sloping front gable roof with no cornice.

STATEMENT OF SIGNIFICANCE

According to Buckeystown, A Village Remembered,<sup>1</sup> the cannery industry was started in 1892 by William G. Baker, Augustus Webb Nicodemus and Otho J. Keller. The Frederick City and County Directory, 1892, lists the Buckeystown Packing and Canning Company with Otho J. Keller as president and William Baker, secretary, treasurer.

A newspaper article from the Frederick News-Post dated August 21, 1921 described the industry as follows:

Another important Buckeystown Industry is that of the Buckeystown Packing Company. During canning season this company employs a great number of persons residing in the vicinity for corn packing purposes. Rather than diversify its activities over several lines of products, the company restricts its operations to the packing of corn with the result that its products are well known and favorably received throughout the country.

The buildings operated as a cannery under the Baker family until the late 1920's. In the 1930's the cannery was operated under George Leicester Thomas, Jr. who sold the business to Henry Koontz of Pennsylvania. In 1948 Randolph Nock purchased the property and until 1953 the buildings were operated as the Buckeystown Canning Company.

The canning operations were shut down permanently in 1953 when the property was sold at public auction. Currently the buildings are used for warehousing.

## Buckeystown Packing and Canning Company

The third building located on the east end of the set of cannery buildings, appears to be the oldest of the three. The building, a one and one-half story whitewashed stucco over brick structure, is also the smallest of the three buildings.


The stucco building is five bays long and one bay wide. The first, third, and fifth bay are occupied by double hung 6/6 windows covered with vertical iron bars.

Located in the second and fourth bays are twin diagonal plain doors with large strap hinges. The east side of the building is five bays wide with double hung 6/6 windows covered by vertical bars. The south side of the building is one bay wide which was occupied by a large sliding door, but has been boarded up. The door has been partially enclosed by cinder block. The north side of the building is identical to the southside.

Three frame cupolas with double four pane windows are located on the top of the gently sloping slate gable roof in the north, south, and center of the building. Two single brick chimneys flank the north and south gable ends.

The entire structure is built on a low random stone foundation which has been stuccoed and whitewashed.


