The Careytown Survey District consists of five frame two-story dwellings built about 1901-1921 on the west side of Pleasant View Road about 1/4 mile south of Doubs. The houses are mostly in the vernacular style based on German building traditions of the mid-18th century into the early 20th century which are characterized by three-bay elevations, two-story perpendicular rear wings, one-story porches, and, by the late 19th century, central cross gables on the principal elevations. Two of the five houses in Careytown have cross gables and three have rear wings. The only exception in style and form in the district is a Four Square type house, the latest of the houses, with a hipped roof, irregular bays, tapered piers with brick bases on the main elevation porch, and a second story screened sleeping porch on the rear elevation. All of the houses have been altered, usually with modern artificial siding and replacement windows and doors, although one house retains its original german siding on the main section. Several have modern additions to the rear and side elevations. The houses are attributed by local tradition to John Carey, a local builder in the Doubs area, the source of the district's unofficial name. The district is moderately significant as an example of a small housing development of the early 20th century and for the vernacular architecture of the houses. The Four Square house is also notable for the virtually unaltered sleeping porch, a common element in early 20th century houses which is often enclosed in later years.

The Careytown Survey District consists of five frame two-story dwellings built from about 1901 to 1921 on the west side of Pleasant View Road about one quarter mile south of Doubs, Frederick County, Maryland. Four of the houses have been altered with the addition of modern artificial siding, one retaining its original german siding, and are, with one exception, in the vernacular style common to Frederick County in the late 19th century, with roots in the German building traditions established in the mid-18th century. The exception is a Four Square house which follows the nationally occurring form popularized in the late 1890's and early 1900's through architectural and builders' pattern books and the catalog buildings of companies such as the Sears, Roebuck & Company. Each of the houses has small outbuildings, most of which are non-contributing, and are used as garages and storage sheds. One house has a contributing frame summer kitchen of about the same date as the main structure. Dates for the houses in the survey district are based on architectural details and land records.

Two of the four vernacular houses have cross gables on the principal elevations and three have a two-story rear wing, adhering to the usual L-shaped plan of German-influenced domestic buildings. The one without a full rear wing has a shed addition on the rear. All five of the houses have one-story porches on the main facades and the characteristic two-level porch of the German vernacular houses is discernible, although most have been altered with full or partial enclosures of the rear porches. The Four Square house has an integral second-story screened sleeping porch, a common element of the type which in this case has not been altered by enclosure.

In the 1982 survey which identified the survey district, a sixth house was included at the south end of the district. This house, 2222 Pleasant View Road, was not included in the district in this survey because of its distance from the other five houses and the heavy intervening foliage. It has also been much altered in terms of its exterior, with modern wood shingle siding.

Following are brief descriptions of the houses in the survey district:

2236 Pleasant View Road: The two-story frame house has a cross gable on the east elevation with asbestos shingle siding and a one-story porch. The porch has elaborate pierced and scroll-sawn trim and brackets with turned columns. The three-bay facade has segmental arched openings and louvred shutters. The sash is 1/1 replacements with small infill sections above each sash. The door has a segmental arched, three-light transom and sidelights. The door is a modern replacement. The cross gable has a 2/2 Gothic arched window. The roof is standing seam metal and the original interior end chimneys have been removed. The north gable end has an exterior concrete block flue. The sash on the north and south gable ends is 2/2 and appears to be original. The two-story rear wing extends from the northwest corner of the main section. Land records indicate that the house was

The Careytown Survey District is moderately significant as an example of an early 20th century housing development built on part of the Michael farm, a large family holding between Doubs and Point of Rocks. The houses are attributed by local tradition to the builder John Carey, one of several Carey brothers whose family settled in the area of Doubs and Adamstown in the late 18th century. At least two of the houses in the district were built for two of the Carey brothers, probably as rental properties. These connections with the Careys gave the group of houses the unofficial designation of "Careytown". The district is minimally significant in architecture for the vernacular style of most of the houses, which reflect the German influence in their general plans and exterior features and also the typical mid and late 20th century alterations of artificial siding and roofing, additions, and replacement doors and windows. The influence of national architectural styles of the early 20th century is reflected in the presence of a Four Square type house which retains an original sleeping porch in virtually unaltered form, although the rest of the house has modern siding and a large addition on two elevations. A Four Square house of similar design in Doubs (F-1-182) is also thought to have been built by John Carey.

The context of small housing groups such as Careytown in Frederick County as a whole is difficult to analyze, as many such districts appeared from at least the beginning of the 19th century well into the 20th century and were demolished or expanded with non-contributing buildings in modern housing developments. Those that had fully developed plans such as Rosemont near Brunswick achieved the appearance of planned early 20th century suburbs. Careytown exemplifies the type of loosely organized groups of houses which were usually located on the main roads at the edges of large farms, from which the land was purchased or subdivided by the owner for speculative rental properties or for associated family houses. Nearby is the Pleasant View Survey District (F-1-139), a late 19th century settlement of freed slaves from Moreland (F-1-164), a large plantation adjacent to the settlement. Where Pleasant View eventually had a church and a school, two characteristics of a community, Careytown was never envisioned as a community center, but more as an outlying residential group associated with the village of Doubs.

probably built about 1901 by James Carey, possibly as a rental property. In 1914, it was sold to Walter H. and Myra N. DeLauter, who retained the property until 1953. Since 1954, it has been owned by William E. and Ruth M. Davis.

2240 Pleasant View Road: This house also has a three-bay east elevation with a cross gable and a one-story porch. The exterior is covered with vinyl siding. The porch has Tuscan columns and the center entrance has a transom and sidelights with a four-panel door. The windows have 1/1 replacement sash and modern louvred shutters. The central gable window has a Gothic arch. The gable roof is covered with composition material and a modern exterior brick chimney is located on the south elevation. Instead of the usual two-story rear wing, this house has a one-story shed addition on the west elevation. A modern deck extends from the addition. Built about 1904 by Jacob R. Carey, one of five Carey brothers including the James Carey mentioned previously, the house was undoubtedly an investment property and was sold in 1925. The six subsequent owners up to the present included John W. and Almira K. Talbott, from 1928 to 1982.

2244 Pleasant View Road: The Four Square form of this house sets it apart from the rest of the houses in the survey district. Built about 1921, probably by David and Mary Specht, it remained in their possession until 1959. It has a hipped composition roof with a dormer in the east elevation. The irregularly spaced three-bay facade has a one-story porch with tapered square piers set on brick bases. The exterior is covered with vinyl siding and the windows are 6/6 replacements with modern shutters. Flanking the door in the south bay is a smaller, multiple paned window. The door has a glazed upper panel. At the southwest corner of the house is the integral second story sleeping porch, a common feature in early 20th century houses reflecting then-current ideas about health and the benefits of open-air sleeping areas. A modern one-story addition extends from the west elevation onto the north elevation.

2306 Pleasant View Road: This is the only house in the survey district which still has its original german siding. It has three bays and a one-story porch on the east elevation and a two-story rear wing. The wing has vinyl siding and replacement doors and windows. The center entrance has a four-panel door with glazed upper sections. The windows are 2/2 with replacement shutters. The porch has replaced posts on brick bases supporting the roof. The main roof is covered with standing seam metal and one interior chimney on the north gable end remains in place, the southern chimney having been removed. The house was probably built between April and November 1901 by Clara and Horace H. Smith and was then sold to Alfred Pearson. In 1917, the Smiths repurchased the property and five owners have held the property since, including Florence Spalding from 1925 to 1943 and Joseph and Hilda Talbott from 1943 to 1974. It has been in the Bartlett family's possession since 1974.

2312 Pleasant View Road: The northernmost house in the survey district was built about 1901 by Ella and Charles G. Murray. It has a three-bay east elevation with a one-story porch. The exterior is now covered with vinyl siding and the roof is standing seam metal. The original interior end chimneys

have been removed. The windows have 1/1 replacement sash. The center entrance has a stained glass transom which is not original to the house. The door has a glazed upper panel. The porch has turned columns with scroll sawn brackets. The exposed foundation has been replaced or covered on the exterior by concrete block. The two-story rear wing has a modern shed addition and a screened porch on its west elevation. A modern swimming pool is located just behind the house. The frame summer kitchen is located near the southwest corner of the house and has vertical board and board and batten siding. The roof is covered with modern corrugated metal and the brick exterior chimney is located on the south gable end. The interior of the summer kitchen is whitewashed. A plat of the property filed with a 1977 deed identifies the building as a smokehouse, but the interior does not appear to have the heavily smoke-blackened surfaces found in smokehouses of the period.

This small group of six frame houses, now covered with various types of siding, lines the west side of Pleasant View Road, south of the town of Doubs. They are generally similar in design and orientation to the road, and appear to date from the late 19th or early 20th century. Most are 2½ stories high, gable roofed rectangular blocks, three bays wide with a central doorway cross gable, end chimneys, and porch. These are typical of the I-house as built in Maryland during this period.

The house at 2236 Pleasant View Road, near the south end of the group, is typical of most of these houses and is also the most elaborate and best preserved of the group. It features a porch with unusually fine East-lake ornamentation, a pointed arch window in its cross gable, and slightly curved window and door openings. One house in the group represents another house form typical of this period, the cubical, pyramidal or hip roofed two story frame house, usually three bays wide.

This group of houses is significant architecturally as a representative group of large and substantial late 19th century vernacular houses. The houses are almost completely of one type, the Gothic influenced frame I-house with center gable, as built throughout Maryland during this period. These examples are generally larger and slightly more elaborate than the average I-house of this period; the best of the group is at 2236 Pleasant View Road, which has a fine Eastlake porch and other good architectural details.

This group is similar to some of the houses built in the nearby town of Doubs during the 1870's and 1880's (see F-1-133). The houses are not shown on the 1873 Lake atlas of the county, but are seen on a 1913 U.S.G.S. topographic map of the county.
