DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Located on the west side of the B&O Railroad tracks at the south end of the town of Doubs in southern Frederick County, this two story, three bay wide, gable roofed house faces east toward the railroad tracks. It has a center gable on its principal facade, two end chimneys, and a two story ell to the rear. From a distance, it appears to be sheathed with imitation brick shingles.

## STATEMENT OF SIGNIFICANCE

This house is significant architecturally as an example of a vernacular house form seen throughout Maryland during the late 19th and early 20th centuries. It embodies the characteristics of the basic I-house form during this period: two story height, two end chimneys, and three bay facade with central doorway and center gable. It has, however, been altered by the addition of later siding.

The house is not shown on the 1873 Lake atlas of Frederick County, but does appear on a 1913 U.S. Geological Survey topographic map of the county.

The building is of local significance, but does not appear likely to be eligible for the National Register of Historic Places.
