DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This small house is located close to the west side of Pleasant View Road, a short distance north of Route 28, east of Point of Rocks in southern Frederick County. The L-shaped building with a rear ell is two stories high, two bays wide, gable roofed, and faces east. It is either of frame or log construction, and is sheathed with German siding. It appears to be in poor to fair condition.

STATEMENT OF SIGNIFICANCE

This small house is significant architecturally as an example of a common vernacular house form built throughout Maryland in the second half of the 19th century. The house is shown on a 1913 U.S. Geological Survey topographic map of Frederick County.

This property is of local significance; it is not likely to be eligible for the National Register of Historic Places.


