DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This property is located at the end of a long dirt drive leading from the west side of New Design Road, directly north of the National Register-listed house "Saleaudo", south of Adamstown in southern Frederick County. According to the owner, the present modern house here is built on the site of what was probably a tenant house for nearby Saleaudo. To the south of the house, however, is a large frame bank barn which appears to be in good condition. It is built into a bank which slopes from west to east, and has a projecting forebay on the east side.

STATEMENT OF SIGNIFICANCE

The G. F. Snouffer property is significant architecturally for its large bank barn, an example of a barn type characteristic of Frederick County and the larger Pennsylvania-Maryland region. The property, which has a modern house built on the site of an earlier one, also has local historical interest because of its association with G. F. Snouffer, a member of a family of large landowners in this area.

The Bond 1862 atlas of the county identifies the farm as J. B. Snouffer's. The 1873 Lake atlas calls it "Manor Farm" (the name "Manor Farm" is also applied to some other farms in the area on this map). Here, the owner is G. F. Snouffer; in the listing of leading businessmen and farmers, G. Fenton Snouffer is shown with a settlement date of 1855.
