The N.H. Engle House is a typical two story center gable frame farm house, five bays wide and two story addition with two story open porch extending to the rear of the main block of the house. A carved mantal piece with patterna motif and fine beading is located in the south room on the first level.

The N.H. Engle house and accompanying outbuildings is a fine example of a late 19th century farm in the southern part of Frederick County. An unusual architectural feature in the frame bank barn is an arched stone storage area which runs the length of the barn and was probably used for dairy products.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The N. H. Engle House is a typical two story center gable frame farmhouse which faces west from the east side of Ballenger Creek Pike.

The principle facade is five bays wide. The main entrance, an arched paneled door with two light transom and three side lights is located in the third bay. Double hung 6/6 windows with louvered shutters occupy the remaining bays on both the first and second levels. A one story three bay wide columned entrance porch with dentiled cornice extends between the first and fifth bays on the first level. A center gable with arched window extends from the roof over the third bay. A carved mantelpiece with patterna motif and fine beading is located in the south room on the first level.

Extending to the rear of the main block of the building is a five bay wide two story frame addition with two story open porch on the south side. Three entrances, paneled doors with three light transoms enter onto the porch.

The entire structure is built on a low random stone foundation. The building is covered by a standing seam tin roof which is connected by a boxed cornice with return.

Four single brick chimneys extend from the roof of the building in the east, north and south gables and in the center of the rear addition.

A small stone springhouse with brick gable in the east end is located in the front yard of the residence.

A small one story farm stone addition has been made to the south side of the outbuilding.

A frame nineteenth century bank barn is located south of the farmhouse. A very unusual arched stone storage area extends through the entire first level of the barn.

STATEMENT OF SIGNIFICANCE

The N.H. Engle House and surrounding buildings is a fine example of a late 19th century farm in the southern part of Frederick County.

The stone cave running beneath the frame barn located on the premises is an unusual architectural feature. Because of the existence of shelves in the cave, it is probable that it was used for the storage of dairy products.


