The Dixon-Murray Farmstead is a good example of the preservation of an early 19th century log structure by adapting it as the rear service wing of an early 20th century house. Built as a simple two-bay structure about 1830, probably by James Dixon, the log house was later covered with german, then asbestos shingle siding. In 1907, a two-story frame house with shingled cross gables was built adjoining the log structure by Harvey J. Murray. A shingled gable was added to the log structure to unify it visually with the newer section. The 1907 section was modified in recent years with the addition of a two-story extension on the north side. In the 1830's, a small log summer kitchen or smokehouse was built near the log house and in 1907, a small bank barn and several agricultural outbuildings were built west of the house.

The Dixon-Murray Farmstead is centered on a two-story log and frame dwelling built in two periods, about 1830 and about 1907, with the two sections clearly defined by the exposed log structure of the earlier section which became the rear wing of the 1907 house. The farmstead also includes a log summer kitchen or smokehouse of about 1830, a frame and stone bank barn of the early 20th century, and a row of attached frame sheds of the same date. The farmstead is located on the west side of Elmer Derr Road about 1/2 mile west of Ballenger Creek Pike near Feagaville, Frederick County, Maryland. The property is separated from Feagaville by U.S. 15-340 and by Ballenger Creek. The principal elevation of the house faces east. Dates of the buildings were based on land records, architectural details, and a 1907 dated stone gatepost.

The original section of the house is a two-story log structure which until recently was covered with asbestos shingles over german siding. The interior of the house was much altered during the latest in an on-going remodeling of several stages. The south elevation of the log building was apparently its principal elevation. It has two bays and a central cross gable with a shingled surface, a feature added in 1907. The door in the west bay and the windows and frames are recent replacements. The windows are 6/6. The 1907 section is a two-story building with german siding, a cross gable with diamond-patterned tiles and a Palladian-influenced window, and a one-story porch. The east elevation has three bays with a center entrance. The glazed panel door has a plain transom. The first story windows are large 1/1 openings with replacement shutters. The second story windows are more narrow and the shutters have recently been removed. The porch has chamfered posts, the inner two being original and the outer two being recent matching replacements. A small scroll bracket adorns the posts. The roof is covered with composition material and interior chimneys rise at the north and south gable ends. The south elevation has a single off-center bay and a shingled gable. The north elevation has a modern addition recently completed. It encompasses the north side of the original log structure and has a cross gable on the east elevation. The addition is covered with vinyl siding.

Summer kitchen/smokehouse: The log structure located south of the rear wing of the main house has the appearance of a summer kitchen, with vertical siding, a rebuilt exterior brick chimney and a vertical tongue-and-groove door flanked by a large 6/6 window in the east elevation. The roof is covered with corrugated metal. A single window opening is in the west elevation. According to Ms. Rollman, the current owner, the interior was blackened by smoke, indicating that it may have served both cooking and smoking purposes in its years of domestic use. It is now a storage and garden shed. The building was probably built about 1837 with the original section of the house.

Barn: The small bank barn appears from its sawn interior members to have been built about 1907 at the time of the corresponding addition of the main house. It has

The Dixon-Murray Farmstead is primarily significant in architecture for the log structure of the circa 1830 section of the dwelling. The joining of the two sections, the log wing and the frame main section of about 1907, is a good illustration of the preservation of an existing early 19th century structure to serve as the service wing of an early 20th century house. Though this was a frequent occurrence in the 19th century, the Dixon-Murray House is a very clear-cut example, owing to recent removal of artificial siding on the log section. The log house was probably built by James Dixon, according to testimony taken in an 1855 equity case involving the property. Although no deeds were produced in the case to substantiate Dixon's acquisition of the originally 28-acre parcel, one Edward Schley stated for the record that James Dixon died in May 1835, leaving a wife, Sophia, who died about 1852, and eight children, among whom was Benjamin Dixon, one of the complainants in the equity matter. Schley said Dixon died leaving real estate near Phleeger's Mill (on Ballenger Creek) and that it was "but a small house and lot". In the absence of other records to the contrary, this seems to refer to the log house. The outcome of the case was that George Hardt purchased the property for \$1200 in April 1856. Although the intervening transfers are unclear, in August 1872, Joshua T. Murray bought the farm for \$850 and in 1897 conveyed it to Harvey J. Murray, who was probably the builder of the 1907 section.



has vertical siding and a standing seam metal roof. Its siding is partially removed and somewhat deteriorated. Ms. Rollman plans to restore the missing siding.


Sheds: The row of attached frame sheds north of the barn includes two open-sided equipment sheds with vertical siding and corrugated metal shed roofs. Between the two equipment sheds is what appears to be a chicken house with vertical siding and a shed roof. A horizontal window opening is in the east elevation. A second small chicken house stands by itself between the sheds and the dwelling. These outbuildings all appear to date from about 1907.




 County, 1858







