The Curtis Thomas Tenant House is located on the Waters-Thomas Farmstead property (F-1-198) and was built about 1900 as a rental dwelling, possibly for farm workers. It is a fair representative of the early 20th century vernacular house, although the artificial siding and roofing and the generally deteriorated state of the house lower its historical integrity. The house's original german siding is partially revealed on the first story.

SECTION 7: Description:

CONTRIBUTING RESOURCE COUNT: 1

The Curtis W. Thomas Tenant House is a two-story frame dwelling currently covered with asbestos shingle siding built about 1900 on the east side of New Design Road about 150 yards north of the intersection of Mountville Road near Adamstown, Frederick County, Maryland. The principal elevation faces west and the house has no other buildings associated with it. The date of the building is based on architectural details.

The house has german siding under the artificial shingles, revealed in a section of the east elevation where the shingles have been removed. The general condition of the house is fair, with deteriorated sections of roofing and siding. The first story has three bays with a center entrance and the second story has two bays. A one-story porch with turned columns, also in a deteriorated state, shelters the first story. The windows are 2/2 and the north and south gable ends have only small attic windows near the roofline. The roof is covered with diamond shaped composition shingles. Interior end chimneys are at each gable end. The east elevation has two bays on each floor. The first story north bay is concealed by a one-story shed-roofed extension with a modern door on the east side. The interior was inaccessible for this survey.



SECTION 8: Significance:

The Curtis W. Thomas Tenant House is minimally significant in architecture as an example of a vernacular dwelling of the first decade of the 20th century. Much of its simple form and its lack of outbuildings is related to its apparent purpose as a tenant house on the Thomas farm (F-1-198). The exterior materials have been replaced or concealed, reducing its historical integrity. The Waters-Thomas Farm on which the house is located became the property of Curtis W. Thomas in a division of the Waters farm into two 185-acre farms, each being sold to two Thomas brothers by their father George Thomas of Henry, about 1879. The Thomas family still owns the property.
