The Hargett House is a good representative of the mid-19th century dwelling, retaining the German siding and three-bay elevation with apparently original sash and shutters. Its principal elevation on the east also has a four-panel door and a small transom. The rear wing has shed porches on the north and south sides. The property has two concrete block garages built in the early 1920's with cross-braced tongue-and-groove doors. The house was built possibly as early as 1850, based on the 1858 Bond map, which shows a structure owned by G. Thomas. Land records indicate that Gabriel Thomas' widow sold the property to Harriet Hargett, the wife of John H. Hargett, in 1864. The Hargetts owned the house from 1864 to 1920; from 1920 to 1953, two generations of the Walter G. Whipp family were the owners, who probably built the two garages.

SECTION 7: Description:

CONTRIBUTING RESOURCE COUNT: 3

The John H. Hargett House is a two-story frame dwelling built about 1850 with two concrete block garages of the early 1920's located on the west side of Ballenger Creek Pike about 1/2 mile north of the intersection of Manor Woods Road near Adamstown, Frederick County, Maryland. The house faces east toward the road and the garages are located immediately west of the house. The german sided house is currently unoccupied and in fair condition. The dates of the buildings are based on architectural details, historical maps, and land records.

The dwelling has a three-bay east elevation with a center entrance. The facade has no porch or stoop in front of the doorway and the german siding reveals no evidence that a porch was removed. The door is a 4-panel design with a narrow three-light transom above it. The windows are 2/2 with louvred shutters. The cornice is boxes and returns on the north and south gable ends. The roof is covered with standing seam metal. Interior end chimneys were originally at each gable end, but the north chimney has been replaced by an exterior brick chimney. The south gable end has one bay near the front of the house and two 2/2 attic windows flanking the interior chimney stack. A small 2/2 casement window is located on the second story near the rear of the house, possibly an early 20th century addition to light a bathroom. The north elevation also has a single bay at the front of the house. A two-story wing extends from the center of the west elevation, with one-story shed porches on both the north and south sides. Each side has an entrance with glazed panel doors. A third interior chimney is at the west end of the wing. The interior was not accessible for this survey.

Garages: The two garages built in the early 1920's are of plain concrete block. One of the garages has a hipped corrugated metal roof and 2/2 metal sash windows. The double swing doors on the north elevation have cross braced tongue-and-groove panels with centered 9-light windows. The second garage was also once a one-story building, but was altered later with a second story. The hipped corrugated metal roof and swing doors are similar to those on the other building. Both levels have metal 2/2 windows. Parts of the upper structure have wood siding.



SECTION 8: Significance:

The John H. Hargett House is moderately significant for its vernacular architectural style which represents the period about 1850. Although changes have occurred in the chimney locations and the state of the interior is unknown, the house exterior is mostly unaltered since the late 19th century. The possible existence of a porch on the main elevation remains unconfirmed, but this feature is commonly found on dwellings of the period. However, the low threshold of the doorway strongly suggests that a raised porch was never present. The house was possibly built by John H. Hargett in about 1864, but the 1858 Bond map and land records seem to indicate that a house may have existed by the late 1850's, when the approximately 1-acre lot was the property of Gabriel Thomas. In 1864, Thomas' widow sold the lot to Harriet Hargett, the wife of John H. Hargett. Although no specific information about Hargett has been found for this evaluation, the Hargett family was prominent in the affairs of the vicinity of St. Matthew's Lutheran Church, located just south of the house. The 1873 Titus Atlas map shows that a carpenter shop was located north of the house, suggesting by its proximity to the house that Hargett may have been involved with this business. The Hargett family retained the property until 1920. From 1920 to 1953, it was the property of two generations of the Walter G. Whipp family, who probably built the concrete block garages.






