According to local history, Miss Ruth Duvall also operated a millinery shop in the house next door.

In 1931, C. E. Adams purchased the store and converted it into a gas station by adding the overhang on the front of the building.

Today the building is used as a pottery shop and retains the fine stone work also seen in the residences next door and across the street.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Stone House Pottery is a one and one-half story coursed rubble stone building which faces east from the southwest corner of the intersection of Manor Woods Road and Route 85.

The principal facade of the building has been substantially altered from its original configuration.

Currently, the building is three bays wide. The main entrance, a replaced single pane and paneled door is located in the second bay and is flanked by multi-paned picture windows in the first and third bay.

A large overhanging box columned porch which once accommodated gas station functions extends from the front of the building.

Old photographs show that the original front of the building was also three bays wide with a twin paneled door with three light transom and 6/3 windows with paneled shutters.

The second level, now covered by the roof overhang was three bays wide with a freight door in the center flanked by double hung 6/6 windows. An awning extends over the street between the two levels.

The building constructed in each corner with large stone lintels is two bays deep. Each bay is occupied by a large six or nine pane window. Originally shed roof frame buildings extended from the north and south sides of the building.

The rear of the building has been substantially altered by the addition of a rear porch and windows. The stone has been removed and replaced by brick.

The building which is constructed on a low coursed stone foundation is covered by a standing seam hipped tin roof with boxed cornice.

## STATEMENT OF SIGNIFICANCE

The land upon which the Stone House Pottery is located, and indeed, the entire west side of Buckeystown was once part of Carrollton Manor, but was sold by Charles Carroll to John Darnall in 1764 and renamed "Good Luck".<sup>1</sup> John Darnall was a relative by marriage to Carroll having married his daughter, Molly, in 1768.

In 1794, the property was sold to Philip Sinstock, a merchant who built the Federal style brick residence in the north part of the town.<sup>2</sup> In 1805, George Buckey purchased the property and sold it eighteen years later to Adam Kramer.<sup>3</sup>


