According to Williams, History of Frederick County, Maryland: "In 1899, Mr. Smith erected his beautiful home in Buckeystown. His mother resides with him. He afterwards accepted a position as General Superintendent of all the real estate of Daniel Baker and Sons. He has devoted his whole time to this business in which he has proved himself an able financier."

The house is a two story ell shaped hip roof frame house. The main entrance is an eight panel door with inserted lights, three light transom and three side lights. Until after 1940 a decorative frame porch extended across the front of the residence.

A two story original addition three bays wide extends to the rear of the residence. The south side of this addition which originally accommodated a two story open porch was enclosed after 1972.

Evidence from deed research and the Titus Atlas of 1873 indicates that a building used as the Methodist Episcopal Parsonage stood in the immediate vicinity of the existing house and may have been incorporated in the construction of the house in 1899.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Paul Gressling House is a two story hip roofed with cross gable frame residence which faces east from the west side of Route 85 in Buckeystown.

The principal facade is three bays wide. The main entrance, an eight panel door with inserted lights, three light transom and three side lights is located in the second bay. The door is flanked by full length louvered aluminum shutters which are a recent addition. Until after 1940 a decorative frame porch extended across the front of the residence.

Occupying the remaining bays on the first and second level are 2/2 windows with replaced louvered aluminum shutters. A small 2/2 Palladian window is located in the center gable which extends from the roof over the main entrance. A two story three bayed window extends from the main block of the building on the south end and from the first bay of the rear addition on the north side.

A two story original addition three bays wide extends to the rear of the residence. The south side of this addition which originally accommodated a two story open porch was enclosed after 1972.

The entire residence is built on a low random limestone foundation and is covered by a patterned slate roof with fishscale shingling which is attached by a replaced plain boxed cornice.

Evidence from deed research and the Titus Atlas of 1873 indicates that a building used as the Methodist Episcopal Parsonage stood in the immediate vicinity of the existing house and may have been incorporated in the construction of the house in 1899.
