The Emily Driscoll House is a two and one-half story frame cross gable roofed Carpenter Gothic residence covered with German siding.

The main entrance is an unusual seven paneled door with arched three light transom, segmented sidelights, and colonnaded supports decorated with rosettes.

A very decorative frame porch with turned columns and simple post railing extends across the front of the house. Decorating the cornice area of the porch are pinwheel brackets with dropped pendant moldings and guilloche frieze design.

The house was built in 1900 by Newston Schaefer, local builer, soon after one acre of land was purchased from Charles and Sarah Thomas for \$400.00 by Cornelius Oliver of Fairfax County, Virginia.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Emily Driscoll House is a two and one-half story frame cross gable roofed Carpenter Gothic residence which faces west from the east side of Route 85 in Buckeystown.

The principal facade of the building like many of the residences in Buckeystown is five bays wide. The main entrance, an unusual seven paneled door with arched three light transom, segmented side lights and colonnaded supports decorated with rosettes is located in the third bay. Occupying the remaining bays on the first and second level are Victorian arch 2/2 windows with louvered shutters.

A very decorative frame porch with turned columns and simple post railing extends five bays wide across the front of the residence. Decorating the cornice area of the porch are pinwheel brackets with dropped pendant moldings and guilloche frieze design.

A segmented Palladian window similar to other buildings in town occupies the center gable.

The main block of the building is two bays wide. An original two story frame addition with two story open porch on the south side extends to the north rear of the building. The entire building is covered with German siding and is built on a low random stone foundation.

The roof is covered by patterned slate with fishscale shingling. Three single brick chimneys with openings at the top straddle the gables on the north, south and east sides.


