The Augustus Nicodemus House was built in 1874 by Nicodemus soon after he purchased the thirty-four acre farm from Daniel and Catherine Baker for \$3,817.34.

According to Williams, History of Frederick County of 1906, "It is now one of the most desirable homes in the county. It is equipped with a comfortable two story brick dwelling, a bank barn, and all the necessary buildings. Mr. Nicodemus, assisted by his son, Augustus W. Nicodemus, Jr. then engaged in the creamery business in Buckeystown.

Mr. Nicodemus afterward put his son in charge of the business, and accepted a position as general manager of the Buckeystown Packing Company. He was one of the organizers of the company and held some of the stock. He remained with the company until he retired from business in 1906.

Augustus Nicodemus died in 1909 leaving his farm to his son, Augustus, at his death. In 1923, the property was sold out of the family to Blair Smith. It still serves as a private residence and is part of the Buckeystown Historic District.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Augustus Nicodemus House is a two and one-half story whitewashed gable roofed brick residence laid in common bond which sets on a hill at the entrance to the town of Buckeystown.

The principal facade is five bays wide. The main entrance, an original paneled door with three light lower paneled side lights, scroll shaped and rectangular fanlight transom occupies the third bay.

Occupying the remaining bays on the first and second levels are 2/2 windows with hood moldings. Louvered shutters flank each window on the first level.

A columned frame porch extends across the entire front of the building on the first level replacing an earlier ornate Victorian porch. A two story original brick addition four bays wide extends to the rear of the main block.

An ornate entrance porch, one bay wide with slatted railing covers a rear entrance to the residence.

A two story open porch once graced the south side of the addition, but has been enclosed. A smokehouse is attached to the rear addition and contains bake ovens.

The entire building is constructed on a low random stone foundation and is covered by a slate roof with stepped brick cornice.

The interior contains most of its original molding and two marble fireplaces in the dining room and parlor.

Two barns and several utilitarian outbuildings are located on the property.


