Holy Trinity Episcopal Church was built in 1912 as a subsidiary chapel to St. Paul's Church (F-1-130; National Register). Its design features unusual battered buttresses at the corners of the main section, the corner bell tower, and between the side elevation bays. The tower has entrances on both the north and west elevations, with etched glass transoms. The windows and doorways have Gothic arches and a circular window is located in the west elevation. Since 1978, a concrete block addition has been built on the south side of the church. The original building of the church was begun in 1887 near the Potomac River in Point of Rocks, a date commemorated in the inscribed brownstone block at the tower base of the present building. The 1889 flood which destroyed Johnstown, Pennsylvania, as well as a wide area of the Mid-Atlantic Region, also submerged Point of Rocks and the unfinished Holy Trinity Church. After a 23-year hiatus, the church was begun again on the present site above the flood plain. It is significant for the streamlined Gothic Revival architectural style, possibly the design of an architect who is not yet identified, and for its role in the development of the town of Point of Rocks.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Holy Trinity Church is an unusual one story brick Gothic church, which faces west from the south side of Kanahwa Avenue on a hill overlooking Point of Rocks. The church is three bays wide and four bays deep. Two main entrance twin paneled doors with etched and stained glass triangular transom and triple header arches are located in the belfry tower on the first level.

A square brick belfry with triple Gothic arches on each side extends two stories in the northwest corner and is supported with brick buttresses.

Small segmented stained and etched glass Gothic windows with bull's-eye type decoration in each corner, occupy the remaining bays on each side of the building.

Small brick buttresses are located between each bay on the north and south sides. A circular stained glass window is located in the west gable.

The steeply sloping front gable roof is covered with patterned slate and is attached to the structure by a plain boxed cornice.

The entire building is constructed on a low stuccoed stone foundation. A corbeled brick chimney rises from the southeast corner of the building.

Holy Trinity Episcopal Church (currently First Baptist Church of Point of Rocks) is a one-story brick church built in 1912 on the south side of Kanawha Avenue about one-half block east of Ballenger Creek Pike in Point of Rocks, Frederick County, Maryland. The church has a northwest corner bell tower with two sets of entrance doors facing east and north. The corners of the bell tower and the main sanctuary section of the church have distinctive battered buttresses. The same buttresses demarcate the four bays on the north and south elevations. A one-story concrete block addition adjoins the entire length of the south elevation. The church has a brownstone block at the northwest corner of the bell tower with the name "Holy Trinity Chapel" and the date 1887. This date refers to the original building located near the edge of the C&O Canal and the B&O Railroad tracks in Point of Rocks which was destroyed by a flood in 1889 before its completion. Miss Cornelia Hickman, a 92-year-old resident of Point of Rocks, remembers the date of the current building's erection as 1912, the same year in which her father built the house in which she still lives (see F-1-183). Land records confirm that the site of the brick church was purchased in 1912 by the Church Extension Society of the Diocese of Maryland and the deed states the building was being erected at the time of the purchase.

The church is laid in 6:1 common bond with the principal gable elevation facing west. The tower at the northwest corner breaks the line of the gable slope. The facade of the sanctuary section has a circular window with colored glass panes outlined by three receding courses of headers. Below the window are two Gothic arched narrow windows with etched central panels surrounded by colored glass and brownstone sills. The tower has three narrow Gothic arched openings to the bell chamber and Gothic arched transoms above each of the double-doored entrances in the west and north sides. The transoms have the same glass as in the main windows. The roof of the church is covered with composition, replacing the patterned slate pictured in the original inventory photos in 1978. The tower roof is hipped and originally terminated in a cross, which has been removed. Crosses were also located in 1978 at the gable peaks of the east and west ends; they have also been removed. The roof has extended eaves covered with tongue-and-groove soffits. A projecting vestry is located at the southeast corner, adjoining the concrete block addition built after 1978. An interior chimney with a corbeled cap is located near the vestry projection. The exposed stone foundation on the south and east sides has been plastered with cement. The interior of the church was inaccessible for this survey.

Holy Trinity Episcopal Church is moderately significant for its architecture, a streamlined Gothic Revival style which may have been designed by an architect who has yet to be identified. The unusual battered buttresses are distinctive in the design, although most of the other elements of the building's exterior are fairly common. It shares the typical plan of many rural churches of the late 19th and early 20th century in Frederick County, having a corner tower with the entrances, and a rectangular main section with Gothic arched windows and doorways. The church is also of moderate significance in the context of the development of the town of Point of Rocks. The original Holy Trinity Chapel was built beginning in 1887 for the convenience of parishioners of St. Paul's Church (F-1-130; National Register), located about 1-1/2 miles north on Ballenger Creek Pike. The 1870's through about 1920 was a period of moderate expansion in the town and the chapel was apparently meant both to facilitate attendance and perhaps eventually to replace St. Paul's Church, which had been considerably damaged during the Civil War. In 1912, houses were beginning to be built along the present Kanawha Avenue and the location of the imposing brick church underscored the shift of non-commercial building activity away from the original main streets, Clay and Commerce Streets.

The chapel was built, according to a Centennial address at St. Paul's in 1943 by Reverend B. Duval Chambers, near the Potomac River, where much of the town's commercial, residential, and civic activity was centered, along the routes of the canal and the railroad which were its main economic bases. Before the chapel was finished, however, the 1889 flood inundated the town, submerging the church up to the eaves. Rev. Chambers stated that this was the reason for the relocation to the hill above the flood plain, but the cause of the 23-year gap between the two events is unclear. It is possible that the congregation decided to continue at St. Paul's during the rebuilding of the town. The church lot was purchased from Dr. Richard W. Trapnell, a well-known local physician, who arranged in the deed for a burial vault under the church for his family members. Since 1974, the First Baptist Church of Point of Rocks has owned the building.












