As early as 1858, the Bond Map indicates that this vicinity was settled and farmed by the Zimmerman family.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This farm consists of a two and one-half story frame residence with gable roof, a two story outbuilding and frame and brick barn which sit in a complex on the east side of Ballenger Creek Pike.

The residence is four bays wide. The main entrance, a four panel door with three light transom, is located in the third bay. Double hung 6/6 windows with storm windows occupy the remaining bays on the first and second level. A two story three bay wide addition extends to the rear of the main block. The structure is covered by a black corrugated tin gable roof attached by a plain cornice. Much of the architectural value of the building has been lost by the removal of trimwork and addition of aluminum siding over the entire building.

Of interest on the property is a brick and frame outbuilding and barn. The outbuilding is two bays wide. The first level and foundation are constructed of whitewashed brick laid in common bond.

The second level is frame covered by aluminum siding. A two story frame open porch extends along the north side of the building. A single brick chimney rises from the southeast corner of the building. The structure is covered by a corrugated tin roof.

A fine frame, brick and stone bank barn is also located on the premises. The first level, a high coursed stone foundation supports a two story brick wall on the north and south gable ends. Iron bracing rods extend the full length of the barn. The upper part of the gable ends are frame as is the east side of the barn. Four frame louvered vents are located in the brick walls on each gable end. Two other openings with wood doors are located in the stone foundation on the gable ends. The structure is covered by a corrugated tin gable roof.

Much of the original strap hinge hardware remains intact in the barn particularly in the animal pen area on the first level.

This barn is unusual for the use of three materials (wood, brick, and stone) in its construction. Few barns in the area are built of brick, and remain in such good condition.


