The Petersville African Methodist Episcopal Church is one of the first recorded congregations to purchase property and build a church following the end of the Civil War in Frederick County.

The building is constructed in a simple vernacular style with vertical board and batten framing and arched windows in the front gable which is not often seen in public buildings in this county. Although in poor repair, the building is significant to Petersville architecturally and historically in the development of the town.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Petersville African Methodist Episcopal Church is a one story vertical board and batten rectangular building which faces east from the west side of Route 180 down a lane in Petersville.

The principal facade is three bays wide. The main entrance, which is reached by a set of replaced unfinished wood stairs in poor condition, is located in the second bay. The entrance consists of twin original pinned two recessed panel doors with plain cornice which originally had a row of applied circular moldings which have been removed. The hardware on the door has been removed except for a white porcelain doorknob which was added later.

Occupying the remaining bays on the first level are double hung 2/2 windows with several panes broken or missing. Located in the gable over the first and third bays are small double hung 2/2 arched windows which have been boarded shut.

The meetinghouse is three bays deep with double hung 6/6 windows, several of which are in disrepair and boarded shut, located on each side.

A vertical board door is located in the northeast corner of the building. Two single exterior cinder block chimneys rise from the center of the north and west walls.

The entire structure is constructed on a low random stone foundation and is covered by a replaced sectioned tin roof with replaced boxed cornice.

The interior of the building has not been changed. It is bordered on each wall by beaded vertical wainscoting. A semicircular sawnwork railing surrounds the colonnaded pulpit which is flanked on either side by turned column fern stands. The interior windows are surrounded by plain wood molding with shallow triangular pieces over each window. The pews are not a fixed part of the furniture and appear to date later than the building.

A small graveyard is located west of the church.

STATEMENT OF SIGNIFICANCE

The Petersville African Methodist Episcopal Church is one of the first recorded congregations to purchase property and build a church following the end of the Civil War.

On December 30, 1868 a deed for one acre of land and right of way for "free ingress and egress to said church was purchased from Charles and Elizabeth Hardey.¹

The building is still functioning for its original intended use in the community of Petersville.
