Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

The current assessment was prepared on behalf of Duke Energy North America as part of cultural resources investigations to support the proposed construction of a power plant in southern Frederick County near Point of Rocks (Goodwin 2001). The assessment is based on previously existing documentation available at the Maryland Historical Trust confirmed by a reconnaissance survey of the property taken from the public right of way.

The Sunnyside Methodist Church is an example of a vernacular country church constructed in 1899 by an African-American community established by freed slaves after the Civil War. This building possesses the qualities of significance under Criteria A and C. It represents an important aspect of African-American history in Frederick County (Criterion A) and is a good example of a rural church (Criterion C) (Davis 1991).



The Sunnyside Methodist Episcopal Church is a one-story frame hall plan church built in 1899 on the south side of Mountville Road in the village of Mountville. The village was settled after the Civil War by former slaves. The first church of 1885 was outgrown by the 1890's and the church members erected the present structure in 1899. It is a good example of a rural vernacular church of the late 19th century. Its central role in the black settlement's life is underscored by the placement of the Mountville School (F-2-44) of 1888 on the same lot.

The Sunnyside Methodist Episcopal Church is a one-story frame, hall plan church built in 1899 on the south side of Mountville Road west of Basford Road in the village of Mountville, near Jefferson in Frederick County, Maryland. The church is located about 30 yards off Mountville Road with a cemetery on its south and east sides and the Mountville Colored School (F-2-44) located at the north end of the one-acre lot on which the church stands. The principal elevation faces north with double doors and a small belfry over the north gable end of the building. The exterior is covered with german siding and the roof is standing seam metal.

The north elevation has no windows, but the entrance doors have a three-light transom. The doors are modern flush type. A single globe light is above the doors. At the northeast corner of the foundation is an inscribed stone which reads "Sunnyside M.E. Church, 1899". The east and west elevations have three bays each with Gothic arch windows of colored glass. The stone foundation is exposed on the side and rear elevations where the land slopes down to the south. A single brick chimney is located in the east slope of the roof. The south elevation has a projecting bay cantilevered over the foundation, lit by narrow 1/1 windows on the sides of the projection. A single door is located near the southwest corner the building.

The interior of the church was inaccessible for the survey. In 1974, the church was reported to have a wood stove and kerosene lamps which had been in use until the early 1950's and were retained for emergency use. (Jefferson, 1774-1974, p. 49.)

The cemetery contains headstones dated 1894 to the present. Some stones have been dislodged from their bases.

The Sunnyside Methodist Episcopal Church is a good example with little alteration of a rural vernacular church of the last quarter of the 19th century. It was reportedly built by members of the Sunnyside congregation to replace an 1885 building which became too small. The community of Sunnyside was settled following the Civil War by former slaves. By 1882, the settlement was large enough to support a post office, which was named Mountville, as was the main road from Jefferson, which had been originally known as Bridle Road. The church and the 1888 Mountville School (F-2-44) were the center of the village's life, as was customary in black settlements in Frederick County and elsewhere in Maryland.

The original charge included Sunnyside, Jefferson, Middletown, and Braddock Heights.
