The Michael Culler House is a two-story brick Greek Revival house built about 1850 with one surviving stone outbuilding, a meat house. The house is a good example of the Greek Revival style and contains pedimented door and window lintels and paneled mantelpieces typical of the Greek Revival style. It retains a corbeled cornice and central hall plan, typical of early 19th century vernacular houses. Once the center of a working farm, the Culler House and the meat house are located at the edge of an office park built on the former farm property.

The Michael Culler House is a two-story brick dwelling house built about 1850 with a stone meat house of about the same period located on the south side of Maryland Route 340 off Mountville Road near Jefferson, Frederick County, Maryland. The house and outbuilding are screened by trees from the highway and from an office park which has developed on the west side of the original farm property at the east side of Mountville Road. The entrance to the residential group is through the paved area around the office park buildings, at the east end of which a gravel circular drive continues to the house. Its principal elevation faces west toward the drive.

The house has a five-bay main elevation on the west with a one-story porch supported by Tuscan order columns. The walls are 5:1 American bond and the window and door openings have molded lintels with bull's-eye corner blocks. The sash is 6/6. The central doorway has an 8-light rectangular transom and sidelights. The door has 5 panels. In the center bay on the second story is a three-part window. The cornice is corbeled brick and the roof is covered with corrugated metal, probably concealing original wood shingles. The chimneys are located on the interior of the gable ends. The north and south elevations have one window bay each, in which the lintels are plain. The house has a rear two-story brick ell also of 5:1 American bond and with a corbeled cornice. The lintels of the window openings are plain and the roof is also corrugated metal. According to Mrs. James Ingram, the current owner, the rear ell was built about 1754, as evidenced by a dated brick found in the interior. The exterior appearance of the ell so closely matches the character and construction qualities of the main section that this date may be questioned. She also cited 1862 as the date of the main section; however, its interior details suggest the Greek Revival period at its peak, about 1840-60. The corbeled brick cornice is a surviving feature of early 19th century construction.

The interior plan of the Culler House is a central hall with staircase flanked by two parlors on either side. The rear ell adjoins the house at the northeast corner and access to it is via a door in the north parlor. The interior has been much altered in the past 20 years or so by the current owner. Details which are intact are the two mantels in the parlors which have simple recessed panels and flanking unfluted columns and the pedimented overdoor panel with ears and the pediment lintels and paneled bases on the windows in the south parlor. Molded chair rails are present in the main section rooms. The ceilings were lowered by a previous owner and hardwood floors and linoleum tile cover the original wide board floors which are still in place. The staircase has a simple scroll closer detail. The main room in the ell has been the most altered of the main floor rooms. It has a replaced corner stairway, occupying the location of an original enclosed winder stair and built-in cupboards. The modern kitchen occupies the rear or east end of the ell. The original cooking fireplace is still visible but not in use. The ell interior was remodeled in 1971. The south elevation of the ell had an open porch which was enclosed with asphalt shingle siding in 1953. (Continued on page 7.1)

The Michael Culler House is a good example of a Greek Revival vernacular house built about 1850. Its exterior details are mostly intact and are typical: a five-bay, center entry plan with a three-part window on the second floor. The interior has original overdoor panels, window lintels, and mantelpieces with the characteristic pediments, ears, simple moldings, and columns of the Greek Revival style. Once the center of a working farm, the only remaining outbuilding is a stone meat house of about the same date as the house.

The Culler House type and details are fairly common in Frederick County. Many similar examples were found in the Walkersville planning region and it is expected that more of the same style and period of construction will be located in the Brunswick, Adamstown, Urbana, Frederick, and New Market regions. The five-bay brick house is an outgrowth of the symmetrical English settlers houses based on Georgian Colonial designs which proliferated in the southern part of Frederick County in the early 19th century. As German settlers became more prosperous later in the century, they also began building the five-bay type as a standard.

Michael Culler inherited the farm from his father Henry Culler in 1861, but he was residing there prior to the will's date of probate. His name appears on the 1858 Isaac Bond map of Frederick County and also on the 1873 C. O. Titus Atlas map. The farm was described as "the Flook Farm" in the will, a reference to Jacob Flook, the owner from 1824 to 1847. The earliest identified owner was George Ramsburg, for whom the property was surveyed in 1792. The 1754 date mentioned by Mrs. Ingram may be evidence of an earlier house on the site which was replaced by Culler. The Culler family was one of the oldest families in the Jefferson area and owned much property surrounding Jefferson. Descendants of the Culler family owned the farm until 1911.

7.1 Description (Continued)

The meat house, located about 50 feet southeast of the house, is a square plan stone structure with a gable roof covered with corrugated metal. The gables are vertical tongue-and-groove siding. The single entrance door has wide vertical boards and is located in the west elevation.






