Wormans Mill is a four story gable-roofed structure of stuccoed random coursed stone, three (3) bays wide and one room deep. The main entrance located in the second bay on the west side is a paneled door, with three light transom. Some of the double hung 9/9 windows are intact as well as paneled doors with H L hinges on the east and north sides. Located on the south end of the mill is an arched brick raceway.

Until 1978 the mill was part of a farm complex which included a large brick residence, frame barn and corn crib all of which have been demolished.

The first documented mention of Wormans Mill is on July 22, 1804 in the will of Hugh Reynolds who left to his son William Reynolds "100 Acres . . . together with the mills and other buildings there on erected." The mill and property were then sold to John Reynolds, Jr., who in 1822, sold it to Moses Worman for \$8,500.00. According to the 1858 Isaac Bond Map of the county, the building was known as "the old mill" even at that earlier date. The mill was owned by the Worman family until 1915.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Worman's Mill is a four-story, gable-roofed structure of stuccoed random-coursed stone which faces west from the west side of North Market Street extended just north of Frederick, Maryland.

The mill is three bays wide and one room deep. It has been vacated for over twenty years and has deteriorated badly from vandalism and flooding. Some of the double-hung, 9/9 windows are intact as are paneled doors with H-L hinges on the east and north sides. The main entrance, located in the second bay on the west side, is also a paneled door, with three-light transom. Located on the south end of the mill is an arched brick raceway now almost buried with silt from the nearby stream.

The interior of the structure is in extremely poor condition with large sections of the floor missing. An array of broken and rusted 19th century milling machinery is scattered throughout the building.

Until recently the mill was part of a farm complex which included a large brick residence, frame barn and corn crib, all of which have been destroyed.

STATEMENT OF SIGNIFICANCE

Worman's Mill, located just north of the City of Frederick, Maryland, has long stood as a historical landmark to people of Frederick County. It is one of few stone mills still standing in the county.


Originally the land on which the mill was built was part of the "Taskers Chance" tract, which belonged to Daniel Dulaney until the "commissioners appointed to preserve confiscated British Property" sold Lot #27 consisting of 354 acres to John Davidson, Merchant, from the City of Annapolis on October 10, 1781.¹ The cost of the transaction, which included two other smaller properties, was 3,550 pounds. It is not known whether Lot #27 included a mill, but by 1796 when the trustees of John Davidson's estate sold the same lot of 354 acres to Hugh Reynolds for 5,310 pounds, it seems likely that it included a mill.² First mention of the mill is made by Hugh Reynolds in his will written July 22, 1804, in which he leaves to his son William Reynolds "100 acres... together with the mills and other buildings thereon erected."³ The mill and property were then sold to John Reynolds, Jr., who in 1822 sold it to Moses Worman for \$8,500.00. According to the 1858 Isaac Bond Map of Frederick County, the building was known as "the old mill" even at that earlier date. Worman's Mill also had a role in the Civil War. In June of 1863, when the Eleventh Army of the Union Army of the Potomac was enroute to Gettysburg, the troops camped in the fields surrounding Worman's Mill.

The mill was owned and operated by the Worman family until 1915 when William J. Worman died and the estate was sold.

The complex, which once also included several outbuildings, a barn and a beautiful, large brick residence belonged to the Clemson family until the 1970's, at which time it was purchased by a developer, who destroyed all buildings but the mill.

Frederick County Landmarks Foundation would like to acquire this mill, and restore it.


