The Thomas Noland House is a two-story brick dwelling with four bays built about 1804-1808 and a two-story rear wing which was an addition possibly made by 1820. An earlier one-story brick section attached to the eastern elevation has been removed. The entrance has a transom and narrow sidelights with a paneled soffit. Evidence on the weathered painted brick surface indicates that a one-story porch and perhaps an entry porch have both been present at different times, but have been removed. The two-story rear wing has a modern enclosure of a two-story integral porch on the west elevation. A small frame outbuilding of about 1875 at the rear of the house may have originally been a smokehouse. The Noland House is a good example of an early 19th century brick dwelling with elements of the Late Georgian and Federal styles in the four-bay elevation, the paneled doorway, the molded and boxed cornice and the rear wing. Although other houses of the same period are known to exist in the Frederick Region, few have the clarity of form revealed by the Noland House, with its minimal exterior additions.

The Thomas Noland House is a two-story brick dwelling built possibly 1804-1808 with a two-story brick rear wing built by about 1820 with an integral two-story porch which was enclosed after 1946. The house is located just north of I-70 at the end of a long driveway off the south side of Butterfly Lane, part of the southwestern boundary between Frederick (City) and Frederick County, Maryland. The only remaining outbuilding on the property is a small frame shed, although the house was originally the center of a farmstead. The date was estimated by architectural details and the 1808 Charles Varle map of Frederick and Washington Counties.

The Noland House has a four-bay north elevation in 5:1 American bond which has been repaired and repointed, particularly in the spandrels between the window openings of the stories, and has been painted white in the past and is weathering. The surface shows evidence of a one-story porch having been removed and possibly of an entry porch which has also been removed. The entrance is in the inner east bay and has a molded paneled soffit with a four-light transom and sidelights. The door has four molded panels. The door opening has a plain lintel and the windows have flat arches in soldier courses, possibly rebuilt from original gauged brick arches. The sash is 9/6 and the sills are wood. The cornice is boxed and molded. The interior end chimneys rise above a standing seam metal roof. The east and west gable ends have no openings except a pair of 2/2 attic windows flanking the chimney stack. A Frederick County Landmarks Foundation plaque, number 168, is attached to the wall next to the main door. According to information provided by the current owner to the FCLF, an earlier one-story brick section was attached to the east gable end and was demolished possibly about 1870. The two-story rear wing extends from the southeast corner of the main section and a clear joint line in the brick courses indicates that it is a later addition. The bond pattern in the wing is 7:1 American. On its east elevation are three bays in an irregular arrangement with an entrance in the center bay containing a raised panel door. The sash is 6/6 with plain lintels and wood sills. The cornice is boxed. The west side of the wing originally had an integral two-story open porch. This porch was enclosed after 1946 and has pressboard siding with modern sash and entrance door. A central chimney rises from the wing. The interior was not accessible for this survey, but the FCLF registry information sheet refers to three fireplaces on the first story and two on the second story and suggests the mantels and fireplace fixtures are early 19th century. Some original window glass is also mentioned.

The frame shed appears to date from the last quarter of the 19th century or the first quarter of the 20th century. It is generally square with tongue-and-groove siding and a vertical board door in the north elevation. The gable roof is covered with standing seam metal. Its size, lack of windows, and location suggest that it may have been a smokehouse or meat house.

The Thomas Noland House is a good example of a brick vernacular dwelling of the first quarter of the 19th century. Although altered, the basic four-bay design with a paneled doorway, the boxed and molded cornice, and the 9/6 sash, all elements common in Late Georgian and Federal style houses, remain in place. The house was probably built by Thomas Noland, who purchased the property from Christian Getzendanner of Adam in 1804 for 127 pounds sterling. Additional research on the Getzendanner period of ownership may reveal an earlier date for the one-story section which adjoined the two-story existing structure on the east. Noland is identified as the owner of the house on the Charles Varle map of Frederick and Washington Counties dated 1808. The Noland House is typical of many early 19th century dwellings in the County in its considerable level of alteration, but the lack of obscuring porches and other additions on the main section reveals more clearly than most the original form and design.





and Washington Counties, 1808





County, 1858






