The Zion Reformed Church of Charlesville was originally built in 1882, gutted by fire in 1903, and immediately rebuilt. The church is a typical example of the late 19th century rural church in Frederick County, with a hall plan and a projecting bell tower on the west gable end in which the original entrance was located. In 1967, a modern glass-enclosed foyer linking a new education building with the original church was built, changing the entrance from the front of the tower to the northwest corner of the building. The former entrance was closed and a modern stained glass window was placed in the opening, although the transom was retained. Other original exterior features are the Gothic arched windows on the north and south elevations, the patterned slate roof, and the open frame belfry. The exterior brick has been sandblasted and repointed. The church is a fair example of the rural church type of the last quarter of the 19th century, compared to others which retain more of their original features and materials. The Zion Reformed congregation shared the original Bethel Union Chapel (F-3-90) with the Evangelical Lutherans, and formed their own church in 1881, with the church being erected in 1882. When rebuilt in 1903-1904, the principal builder was John H. Wachter, who also was largely responsible for the 1889 Utica Evangelical Lutheran Church. In the last quarter of the 19th century, many of the "union chapels" were transferred to either the Lutheran or Reformed church as new charges were formed to respond to the slowly growing membership in these denominations.

CONTRIBUTING RESOURCE COUNT: 1

The Zion Reformed Church of Charlesville (Faith United Church of Christ) is a one-story brick hall plan church built in 1881 and rebuilt in 1903 following storm damage, located on the east side of Opossumtown Pike about 3/4 mile southeast of the intersection with Bethel Road near Lewistown, Frederick County, Maryland. The building's main elevation faces west toward the road and has a modern one-story glass-enclosed foyer adjoining the original bell tower and replacing the original main entrance through the base of the bell tower. A 1967 Sunday School wing is located off the north end of the foyer, leaving a small partially enclosed section of the church cemetery between the church and the education wing. The rest of the cemetery is located east and south of the church.

The original section of the church has 7:1 bond exterior walls which have been sandblasted and repointed. It has a projecting bell tower on the west gable end through which was a double-doored entrance. This entrance is now closed off and filled with modern stained glass. Above the former entrance is a Gothic arched transom with stained glass of the 1903 period of rebuilding. Above the original entrance in the tower shaft is a small Gothic arched window. The belfry has an open chamber with a slate pyramidal roof. The north and south elevations have four bays with Gothic arched stained glass windows. The roof is patterned slate. On the west elevation is a projection which undoubtedly corresponds to the choir recess behind the pulpit commonly found in other hall plan churches of the period. The interior was inaccessible for this survey. In the cemetery surrounding the east end of the church, the earliest death date observed was 1876, which predates the original church on the site. According to the Williams & McKinsey History of Frederick County of 1910, the original 1881 church was struck by lightning on May 22, 1903 and gutted to the exterior walls by the subsequent fire. The church was immediately rebuilt and rededicated on May 29, 1904. The 1910 history states that John H. Wachter, the principal builder of the Utica Evangelical Lutheran Church in 1889, was the builder of the 1903 church. No photographs of the original church have yet been located, but further research among church records and private collections may provide further information on its appearance and show what changes were made when it was rebuilt in 1903.

The Zion Reformed Church of Charlesville is a fair example of a late 19th century rural church in Frederick County. Its exterior walls date from 1881, and, although rebuilt in 1903 following a fire, its architectural character remains that of the last quarter of the 19th century. The Gothic arched windows and hall plan with a projecting bell tower are common elements found in many Reformed and Lutheran churches in Frederick County. The church has been significantly altered by the adjoining modern foyer and the closure of the original entrance and the replacement of the doors, thus lowering its integrity as compared to some other rural churches, such as the Pleasant Hill Union Chapel (F-3-31), built in 1883-1884, which retains most of its original exterior character, although it is no longer in use as a church. The Zion Reformed Church represents the growth of the Reformed and Lutheran congregations of Frederick County during the last quarter of the 19th century. Prior to about the 1880's, the two denominations often built and shared "union chapels" in several locations throughout the county. After about 1880, the interest of one sect was increasingly purchased by the other with a separate church being established. The Zion Reformed congregation was originally involved in the union chapel at Bethel (F-3-90) from 1838. In 1881, the Reformed congregation separated and built the Zion church in 1882. The name Charlesville refers to the loosely concentrated group of houses and farms in the vicinity of the church, most of which predate the church. The village took its name from Charles Broadrup, a local farmer and landowner with extensive holdings in the second half of the 19th century.


