The Brook Hill School was built as a two-room brick schoolhouse in 1885, replacing an earlier school on the site. The original appearance included a five-bay elevation with double entrances in the center bay and a bell cupola on the roof. After the school closed in 1940, the Yellow Springs Community Association acquired the building and added a projecting foyer over the two doorways. The inscribed stone plaque with the school name and district was retained in the southwest elevation. A concrete block kitchen and service addition was built on the northeast side of the building, perhaps in the 1960's by the current owners, the Yellow Springs Lions Club. The school is a fair example of the late 19th century two-room school plan which has been altered for other uses. Compared with other schools of the period with similar changes in use, the Brook Hill School is fairly typical.

CONTRIBUTING RESOURCE COUNT: 1

The Brook Hill School was built as a one-story, two-room brick school in 1885 on the northeast side of Yellow Springs Road in the village of Yellow Springs about 1/4 mile southeast of the intersection of Bethel Road, near Frederick (City), Frederick County, Maryland. The date is based on land records. In the mid-1940's, after its closure as a school, the Yellow Springs Community Association added a projecting foyer on the southwest elevation. The building is currently in use as the Yellow Springs Lions Club and a concrete block addition containing a kitchen and other service rooms has been added to the northeast elevation. The former school is surrounded by a paved parking area with a lawn between the building and the edge of Yellow Springs Road.

The school has 7:1 brick exterior walls which have been sandblasted and repointed. The raised stone foundation has concrete steps rising to the entrance. The southwest elevation has five bays including the projecting entry foyer. The window arches are gauged and the sash is 6/6 with wood sills. The entrance has a replacement 6-panel door with a transom and sidelights. Modern globe lamps flank the doorway. Above the foyer is an inset stone plaque identifying the building as Brook Hill School No. 3, District No. 21. The roof is covered with corrugated metal. The concrete block addition on the northeast elevation has a shed roof and entrances on the end walls. The interior of the building was not observed, but it is assumed that the original two-room configuration has been considerably altered. In a July 1992 Frederick News-Post article about a quilt recently made by local resident Ruth Brickhouse picturing various historic buildings in the Yellow Springs area, the school is shown with double entrances in the central bay, a central bell cupola, and interior end chimneys. Only one of the chimneys remains in the west gable end.




 Earlier school site


