Based on the available information, the Daniel Kepler Property, located in the vicinity of Bolivar, is eligible for the National Register of Historic Places under Criteria A and C for its association with the development of agriculture in Frederick County and for its association with the events of the assault on Turner's Gap in the Civil War. A portion of the property is included in the Fox's Gap section of the South Mountain Battlefield, included in the National Register of Historic Places. The farmstead consists of a log and frame farmhouse, a meathouse, springhouse, bankbarn, haybarn, and numerous other agricultural outbuildings.





This property is included in the survey of resources associated with the Civil War Battle of South Mountain, which occurred on September 14, 1862. The Kepler farmstead is located in a ravine with limestone outcrops, just south of Old National Road, and just west of the crossroads community of Boliver west of Middletown in Frederick County. Buildings include a gable-fronted two story house, probably of log construction, a timber frame bank barn with enclosed forebay, a wagon shed and various domestic and agricultural outbuildings. The house is situated on the low ground with the barn at higher elevation to its southeast. The wagon shed is located south of the house, also on the lower ground.

The Kepler Farm was in the path of the Union approach to Turner's Gap, and Civil War maps from the Official Records of the War show that General Reno's IX Corps deployed from the southwestern edge of the Kepler farm as they moved into Fox's Gap in an attempt to outflank the Confederates holding Turner's Gap. Historic maps also show a battery of artillery placed in a field just south of the Kepler's farm buildings. The Kepler Farm is also secondarily significant for its architecture. The juxtaposition of the buildings is unusual with the barn at a higher elevation than the house. The house itself is unusual or the region with its gable-front presentation and combined Greek Revival and Italianate decorative features.

The Kepler farmstead is located in a ravine with limestone outcrops, just south of Old National Road, and just west of the crossroads community of Boliver west of Middletown in Frederick County. Buildings include a gable-fronted two story house, probably of log construction, a timber frame bank barn with enclosed forebay, a wagon shed and various domestic and agricultural outbuildings. The house is situated on the low ground with the barn at higher elevation to its southeast. The wagon shed is located south of the house, also on the lower ground.

The house faces east, and is a long rectangle with the main facade being the east gable end. It rests on stone foundations which are fairly high and is of wood construction, probably log with siding which appears to be aluminum. The front elevation is two bays wide with the main entrance in the more southerly bay. It is sheltered by a Greek Revival style pedimented porch supported by four columns. Windows have single pane replacement sash. The front elevation is distinguished by a broad frieze along the gable trimmed with brackets. Chimneys are located inside the gable ends and near the center of the house. The roofing material is sheet metal. The house appears to date from the mid 19th century, probably the 1850s or '60s.

The barn is large with vertical siding and high stone foundations which extend out to support the forebay. The wagon shed with its open gable end faces north toward the Old National Road.

A small stream runs through the ravine just to the northeast of the house. The topography of the farm is hilly with limestone outcrops and wooded fencelines and woodlots. The property extends to the south to Fox's Gap Road near its intersection with Reno Monument Road. It contains 130.50 acres.

The Kepler Farm is important primarily for its role in the Civil War Battle of South Mountain which occurred on September 14, 1862. Located along the south side of the National Road, the farm was in the path of the Union approach to Turner's Gap, and Civil War maps from the Official Records of the War show that General Reno's IX Corps deployed from the southwestern edge of the Kepler farm as they moved into Fox's Gap in an attempt to outflank the Confederates holding Turner's Gap. Historic maps also show a battery of artillery placed in a field just south of the Kepler's farm buildings. The Kepler Farm is also secondarily significant for its architecture. The juxtaposition of the buildings is unusual with the barn at a higher elevation than the house. The house itself is unusual for the region with its gable-front presentation and combined Greek Revival and Italianate decorative features.

During the Battle of South Mountain, the Union objective was to gain access to the passes across South Mountain so that Federals could attack the divided and vulnerable Confederate Army in the valley to the west. The Confederates held a thin line of defense under General D.H. Hill at Turner's Gap which was the main Union objective, since the National Road crossed the mountain through this gap. Expecting the pass to be strongly defended, the Federals initiated flanking movements to the north and to the south of the National Road. General Joseph Hooker's I Corps was selected to skirt to the north while General Jesse Reno's IX Corps was assigned the task of advancing from the South by way of Fox's Gap. The two corps split at Boliver crossroads, a short distance east of the Kepler Farm. In an effort to distract the enemy, General Ambrose Burnside selected Gibbon's "Black Hat Brigade" to approach Turner's Gap directly up the Old National Pike, and initiate a frontal attack.

The Kepler farm sits in the shadow of the hill from which McClellan watched his grand army do battle. From the Kepler House one could have witnessed the movement of the IX Corps down the Old Sharpsburg Road and the I Corps down the Old Hagerstown Road (today's Mt. Tabor Road). The march of Gibbon's Brigade would have passed directly in front of the Kepler House, the column marching through the fields on the left and the right of the road.¹ From the Kepler farm, there was also a good view of the battle as it unfolded. Unfortunately for the Federals, their three-pronged attack was slow and uncoordinated, allowing the Confederates to reinforce their positions. The Confederates also had the advantage of terrain by holding the high ground. As one Union private put it, "the rebels had stone walls to get behind and the

woods to fall back in."² When General Reno went to the front to investigate the slow progress of his Corps at Fox's Gap, he was killed by a Rebel sharpshooter. The 7th Wisconsin, part of Gibbon's brigade was pinned down by flanking fire on the side of the mountain, along the National Road, a short distance west of the Kepler farm. By nightfall, the Rebels still held Turner's Gap, but they withdrew early the next morning realizing that their position could not be maintained.

The Kepler farm is secondarily important as a vernacular farmstead grouping from the mid 19th century. The placement of the buildings on the landscape is unusual as is the exterior plan of the house. The exterior details suggest a construction date from the 1850s or '60s with mixed Greek Revival and Italianate influence. The structure of the house is probably log, as was typical of the region. Most farmsteads in central Maryland do not have the barn at such a distance and so much higher in elevation from the house. The gable-front presentation is also unusual among central Maryland farmhouses.

The Kepler farm is also unusual in that it has been in the Kepler family since 1861. The farm was acquired by William J. Kepler on May 7, 1861 from Ezra Warrenfeltz (Deed Liber BGF 6/ folio 680). It remains in the Kepler family today.




