Based on the available information, the Harding-Keller Farm, located at 12202 Lime Plant Road in southeastern Frederick County, is eligible for the Maryland Register of Historic Properties. The two-story stone farmhouse was constructed in 1830 as the dwelling for a tenant farm. The property also includes an 1830 smokehouse and several later outbuildings. The property is eligible under Criteria C as a fine example of Germanic stone masonry. The modest house features some exceptional touches including the use of shaped stones to form a stepped cornice and the use of natural stones to accentuate the quoining pattern at the corners and to form the lintels over the windows. A datestone adds to the significance, by providing a concrete date of construction.

In addition to being individually eligible, the property is located in an area which retains numerous historic farmsteads within a largely unaltered setting and which may constitute a historic district.

The Harding-Keller House is a good example of German stonemasonry technique of the first half of the 19th century. It is particularly noted for the shaped corbel stones which bracket the boxed cornice with its decorative molding in the Federal style and the large flat lintel stones over the openings and the quoins at the corners. The house is dated 1830 and was built by Christian Harding as a tenant house for the operator of his flour and saw mills located on Ben's Branch just south of the house. In 1848, he devised the mill property and the house to his son William Harding and in 1869, Jacob Keller of J. (1825-1894) bought the mill and the house in an equity sale. He renamed them Fayette Mills and continued their operation until losing the property in a mortgage default in 1897. After that date, the mills were converted to the production of lime. The house once had a log barn nearby, but the only remaining outbuildings are a circa 1830 stone smokehouse and a frame privy and a chicken house of the early 20th century.

The Harding-Keller House is a two-story stone dwelling dated 1830 in a stone in the west gable and its remaining outbuildings, a stone smokehouse of about the same date and a frame privy and a frame chicken house of the early 20th century, all located on the north side of Lime Plant Road about 1.2 miles west of Detrick Road near New Market, Frederick County, Maryland. The house is located in a curve of the public road and faces south toward Ben's Branch where the deteriorated structure of a lime plant is visible. The Harding-Keller House was historically associated with this industrial site, which began as a flour and saw mill and was converted to lime production apparently in the late 19th century. The mill site is on a separately owned parcel and is not described in this inventory form. The dates of the buildings are based on the inscribed date in the gable of the house, architectural details, historical maps, and land records.

The dwelling is currently being rehabilitated and its interior has been considerably altered, leaving little of its original features and finishes in place. The exterior has been repointed in a raised style typical of the early 20th century, repeating the profile of a repointing which was done in the 1940's. The three-bay south elevation has a center entrance with a large flat stone as the lintel and a replacement 6-panel door of the early 20th century. The one-story entry porch was built in the 1940's and has a concrete platform with square posts and a corrugated metal roof. The windows are 6/6 and were replaced in the 1940's. The cornice of the house has a molding with an alternating design of flutes and incised stars in a vernacular version of Federal period trim. The cornice is boxed and is set between shaped corbel stones set in the wall structure at each of the four corners of the house. The roof is covered with corrugated metal. Interior end chimneys rise at the east and west gable ends. The dated stone is in the west gable end just below the rebuilt brick upper level of the chimney. Small attic windows flank the stack in each gable, but no other openings break the stone end walls. The north elevation has a full-width one-story porch, which also has a concrete deck and square posts supporting a corrugated metal roof. Three bays are in each story. The east gable end is abutted by a 1-1/2 story stone wing which contains the kitchen. It has a corrugated metal roof and a box cornice with the same corbeled cornice stops as on the main section. On the south elevation of the wing is an enclosed porch over the doorway and a 6/3 window. On the north side of the wing is another 6/3 window. A 2/2 attic window is in the east end of the wing.

**Smokehouse:** The stone smokehouse built about 1830 is located northeast of the side wing of the house. It has a doorway on the south elevation and smoke vent slits on the north, east, and west elevations. The roof is corrugated metal.

**Privy:** The frame privy built about 1900-1910 has vertical siding and a corrugated metal shed roof. It is located north of the house, although the possibility exists that it may have stood at other locations in the domestic building group.

The Harding-Keller House is moderately significant in architecture for the stonemasonry of the exterior walls, which have shaped corbel stones framing the cornice and large corner quoins and lintel stones over the openings. The house is dated 1830 in the west gable and is a good example of the German building technology of the first half of the 19th century. Its interior has been much altered and the windows, doors, and original roofing have been replaced, but the exterior form and wall materials remain little changed. The house was probably built by Christian Harding as a tenant house for the miller who operated the grist and saw mills also owned by Harding located just south of the house on Ben's Branch. In 1848, Harding's will devised the mill property of 52 acres, including the house, to his son William Harding. In 1869, the property was described in an advertisement for sale ordered by an equity court:

" Harding's Mills . . . containing 52 acres, 12 acres are heavy set in timber, the balance arable, 7 acres of meadow land . . . Improvements are a three-story stone mill running one pair of burs and one pair of country chopping stones, with an excellent saw mill attached . . . The dwelling is large and comfortable, containing about 7 or 8 rooms, meat house, fine dairy, hen house, fine garden . . . The above buildings are built of stone . . . Also a log stable and all other necessary outbuildings . . . Two fine springs."

Jacob Keller of J. (1825-1894) bought the property and continued to run the mill, which he renamed Fayette Mills. In 1897, the house and mill were again sold in an equity sale and at some point after this date the mill was converted to lime production. It was apparently separated from the house and outbuildings during the 1960's and had been inactive for many years. The house and its outbuildings have been in the Thompson family since 1944.

Chicken house: The frame chicken house has vertical board siding and a corrugated metal shed roof. The entrance to the chicken coop is in the center of the south elevation, flanked by openings. The chicken house is located north of the house and northeast of the privy. Its date is apparently about 1900-1910.

The Christian Harding Tenant House displays a very fine example of coursed stonework in the New Market area.

The house is a two and one-half story coursed stone residence, three bays wide with one story coursed stone kitchen addition with exterior chimney located on the east end of the main block. The most unusual feature of the building is the variegated effect of the stonework made up of alternated light and dark stones. Large stone quoins are located in each corner of the building; the top stones serve as the cornice in each corner. Single stone lintels are located over each window and the door.

It appears from deed records that the house was built sometime after 1805 when the property was bought by Christian Harding from John Burkhart. Located in the west gable of the house is a building date of "1830."

## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Christian Harding Tenant House is a two and a half story coursed stone residence which faces south from the north side of Lime Plant Road standing on a hill overlooking Linganore Creek.

The main section of the building is three bays wide; the principal entrance located in the second bay is a paneled door with late nineteenth century hardware and covered by a screen door. A simple shed roof porch, one bay wide, which is an addition to the original building surrounds the entrance.

Located in the remaining two bays are double hung 6/6 windows covered with storm windows. Single large stone lintels are located over each bay.

A replaced tin roof joins the building with a boxed cornice and decorative frieze. A plaque with the date 1830 is located in the west gable. Unusually large stone quoins, some over three feet wide, are located in each corner of the building. The top quoins in each corner serve as the cornice.

A one story coursed stone kitchen addition with an exterior chimney is located on the east side of the main block. The most unusual feature of the buildings is the variegated effect of the stonework made up of alternating light and dark stones.

### STATEMENT OF SIGNIFICANCE

The Christian Harding Tenant House located on the same farm as the Christian Harding House is one of the finest examples of coursed stonework in the New Market Area. It appears from deed records that the house was built some time after 1805 when the property was bought by Christian Harding from John Burkhart. Located in the west gable of the house is a building date of "1830".

The stonework of this building is particularly unique in that light and dark stones were alternately used producing a very unusual effect. The top quoins of the building also serve as the cornice in each corner. Single stone lintels are located over each window.









