Based on the available information, the Captain Ignatius W. Dorsey Farm (also known as "Sedgely"), located at 5620 Detrick Road in southeastern Frederick County, is eligible for the Maryland Register of Historic Properties. The two-story brick farmhouse with Italianate features was built c. 1870. Original outbuildings include a meathouse, wagon shed/corn crib and bank barn. The house was built for a prominent local landowner and reflects the status of the builder through its size, materials and high style detailing. It is significant under Criterion C for the melding of a basic vernacular house type of the mid- to late-19th century with high style details. The popular Italiante style is reflected in the large scale of the house as well as in details of the exterior ornamentation, including porch and window trim, and in the interior trim and decoration. In addition, the intact farmstead conveys a sense of the county's rich agricultural heritage. Sited on a crest, the property enjoys an xpansive view over a largely unaltered agricultural landscape.

In addition to being individually eligible, the property is located in an area which retains numerous historic farmsteads within a largely unaltered setting and which may consititute an historic district.

The Captain Ignatius W. Dorsey House is a large, two-story brick house with Italianate details built about 1870. Its remaining outbuildings include a smokehouse which was originally part of a larger structure, a deteriorated frame wagon shed/corn crib, and a frame bank barn, all built about the same time as the house. The dwelling has a five-bay south elevation with a one-story porch and a cross gable with an arched gable window. The windows flanking the center entrance were originally jib windows, now altered as standard window openings. The center hall plan has parlors on each side with simple molded wood mantelpieces. The walls in the center hall were originally stenciled with an ashlar stone design, which has been partially revealed by on-going restoration. The rear wing of the house has been extensively remodeled, with vinyl-sided enclosed sections where a two-story open porch was originally in place. The house is moderately significant for its architecture, an altered example of the basic vernacular house of the mid to late 19th century with details of a popular style, the Italianate, in its porch and window trim, its interior trim and decoration, and its large scale. It reflects the economic and social status of Ignatius Dorsey (1834-1915), who served in the Union Army and was later a member of the Board of the House of Correction. The setting of the house, with expansive views across open agricultural fields from the crest of a hill, is unusually intact among houses of the same period and type in Frederick County.

The Captain Ignatius W. Dorsey House is a two-story brick house with Italianate details built about 1870-71 on the west side of Detrick Road about 1/4 mile north of the Old National Pike (Md. 144) near New Market, Frederick County, Maryland. The house has a two-story rear wing which has been considerably altered in the 1990's. The remaining outbuildings, all of about the same date as the house, include a frame meathouse located northwest of the rear wing, a deteriorated frame wagon shed/corn crib, and a frame bank barn which has modern metal siding over its vertical board siding. The farmstead also has several non-contributing agricultural outbuildings and is a working dairy farm as well as a private residence. The dates of the buildings are based on architectural evidence, land records, historical maps, and a biographical sketch of Ignatius W. Dorsey in Williams and McKinsey's History of Frederick County (1910).

The dwelling has a five-bay south elevation with a cross gable over the center three bays and a one-story porch. The brick walls are in 6:1 American bond and has been sandblasted and repointed. The center entrance has a three-light transom and sidelights and a door with four molded panels. The windows are replacement 4/4 with a running ornamental molding in the wood lintels. The first story windows flanking the doorway were originally jib windows, but have been converted to sash windows. The original louvred shutters have been removed. 1 paneled jibs have been retained and stored by the owners, Mrs. and Mrs. Jeffrey England. The porch has a scroll-sawn balustrade and square piers which were copied from the deteriorated original porch. The square piers with pedestals are also reproductions of the original porch supports. In the cross gable is a round-arched 2/2 window with a molded hood. The roof is modern composition material replacing corrugated and standing seam metal which was in place prior to the recent rehabilitation of the exterior. Interior end chimneys are located at the east and west gables. On the east elevation of the house is a porch similar to the south porch fronting an entrance in the two-story rear wing which adjoins the main section at the northeast corner. Two additional chimneys rise above the roof at the north and south ends of the wing. The west side of the wing probably had a two-story open porch in its original state. It has been almost entirely enclosed in the recent rehabilitation and has vinyl siding. An open section was left in the center of the second story and a modern one-story porch shelters the entrance. The north end of the rear wing has modern arched windows. The gable ends of the main section on the east and west have two 2/2 attic windows and two bays in the east end, but no other openings in the west end.

The interior of the main section has a center hall plan with a staircase featuring scroll closers and a turned newel post. The walls of the hall were originally stenciled to resemble ashlar stone, but were covered with wallpaper in the early 20th century. A section of the wallpaper has been removed near the second story landing and the Englands plan to remove the wallpaper entirely to reveal the original painting. Molded ceiling medallions in the first story hall and parlors flanking the hall appear to be reproductions. The mantelpieces in the east and west parlors are simple molded designs with a central shield motif. The interior walls,

The Captain Ignatius W. Dorsey House is moderately significant for the architecture of the circa 1870 dwelling, which displays influences of the Italianate style in its large proportions, porch trim, window styles, and interior trim. The interior central hall has stenciled walls in imitation of ashlar stone, partially covered with early 20th century wallpaper. The house has been sandblasted on the exterior, windows have been replaced, and the original porch trim and support piers have been largely reproduced on the south elevation. Considerable alteration has taken place on the rear wing. As with many late 19th century houses in Frederick County, the basic vernacular form of a main section with a perpendicular rear wing is still intact, over which exterior details of a popular style, in this case the Italianate, have been applied. The house was erected by Ignatius W. Dorsey (1834-1915) on land transferred to him by his father Harry W. Dorsey. He called the farm "Sedgely". His brother Pottinger Dorsey retained the Dorsey homestead nearby (see F-5-77). Another brother was Dr. Harry W. Dorsey, a physician in New Market during the period 1866 to 1900. Ignatius attained the rank of captain serving in the Union Army's First Maryland Brigade in the Civil War and for several years was on the Board of the House of Correction. The scale and style of the house reflects Dorsey's social standing and economic status as a large landowner of the period. Its 19th century setting, with expansive views across open agricultural fields from a hill crest, remains largely unchanged, a characteristic which is increasingly rare in Frederick County.

especially in the west parlor, are in deteriorated condition and are under various stages of repair. The plaster has been removed in the northwest corner of the west parlor, revealing the lath understructure. In the rear wing, considerable alteration has taken place, including the removal of an interior wall and the addition of modern arched windows in the north end.

Outbuildings:

Meathouse: The frame meathouse is located just northwest of the rear wing. It has board and batten siding and a vertical board door which appears to be older than the siding. The roof is covered with corrugated metal. The north elevation is covered with plywood. According to the Englands, the building originally had an extension on the north which was demolished, leaving the meathouse as a free-standing structure. The north end may have been a wash house or summer kitchen. The original building was probably built in the 1870's, and was apparently used in later years as a smokehouse as well as a meat storage building, since the interior shows charred timbers in the roof structure.

Wagon shed/corn crib: The deteriorated frame wagon shed is located north of the domestic buildings. Built about 1870-1875, the shed has german siding on the exterior, some of which is missing, and stone piers supporting the cribs on the east and west sides. Above the enlarged opening is a single doorway opening to the loft. The roof is covered with corrugated metal.

Bank barn: The frame bank barn has been covered with metal siding, but retains its general form, with the stall level on the east side. The stalls are partially enclosed with concrete block and a concrete block milk house adjoins the barn on the north end. The milk house roof has distinctive "oil can" shaped vents on the ridge. The roofs of both the barn and the milk house are standing seam metal. The barn dates from about 1870-1875.


