Description of Property and Eligibility Determination: *(Use continuation sheet if necessary and attach map and photo)*

Structure No. 10081X0 (F-6-126), which has been repaired repeatedly, is not eligible for listing in the National Register due to lack of integrity. This structure is a standard concrete slab, built in 1928-32, which has been repaired repeatedly to address structural problems--the north elevation was largely replaced. We have determined that this structure lacks the requisite integrity to be considered eligible for inclusion in the National Register as a type of concrete slab small structure. To be considered for listing, according to the Small Structures on Maryland's Roads, Historic Context Report (p. 4-10) concrete slab small structures should retain parapets, abutments and wingwalls as primary character defining elements of the substructure. Structural damage requiring past repair has compromised the integrity of these elements. The north wingwall collapsed and a new one built in its place in February 2001. Despite this repair, considerable additional structural problems necessitate the removal of this structure.
