The Black's Mill District is comprised of 5 principal buildings and two mill sites located on Black's Mill Road with the focus of the district at Hunting Creek where Black's Mill Road and Layman Road intersect. The district represents an early industrial community that operated from the late eighteenth century through the nineteenth century. Buildings in the district related to the milling industry as residences or nearby farms. Although the industrial structures are no longer extant, the remaining buildings give evidence of a former community centered around Hunting Creek and the mills. By the nineteenth century, it had developed into a crossroads location on the route to larger villages like Creagerstown and Thurmont. Architecturally, the surviving resources were constructed from the late eighteenth century to the mid-nineteenth century. The majority of the buildings are of brick construction with a sophisticated level of design and plan. The other buildings are of log construction typical of the region.

7.1 Description:

The Black's Mill District is comprised of 5 principal buildings and two mill sites located on Black's Mill Road with the focus of the district at Hunting Creek where Black's Mill Road and Layman Road intersect. The district developed by the late 1700s as a result of the milling industry (at least two grist mills) located on the creek. The surviving buildings relate to the original focus of the area as residences for mill owners and workers or as nearby farms associated with the mills.

Three buildings are located in close proximity to the mill sites on the south side of Hunting Creek. One building is on the north side of Hunting Creek. Another building is located approximately 1/2 miles to the west of the mill aligned with a tributary of the creek, Little Hunting Creek.

All of the buildings are two stories in height. Three of the buildings are of brick construction; the remaining two are of frame and log construction. Two buildings have one story stone wings. The buildings show a range of design influences including Georgian and Federal period elements and vernacular log techniques.

Today, the district is residential and agricultural. During the periods of significance for the district, it experienced greater activity through the production of two mills which created a commercial center. Although the mills are no longer standing, the remaining resources are representative elements of a former industrial community.

The Castle House, 7816 Black's Mill Road, is a two story brick building with the principal facade facing east. It is located several yards to the west of Hunting Creek and was probably associated with one of the two grist mills on the creek. Constructed circa 1780, the house has Flemish bond brickwork with queen closers and a watertable on the east and south elevations. All other elevations have 3.1 common bond. It rests on a stone foundation. The gable roof of standing seam tin has two interior end stuccoed chimneys. A wooden molded cornice extends around the building. A three string beltcourse runs across the north and east elevations; the central row is composed of glazed headers. A one story stone and brick wing extends from the south elevation of the main block: it was constructed in two sections and is 3 bays wide. It has a gable roof of standing seam tin and a boxed cornice. Glazed headers are randomly placed. Two interior chimneys, end and center, are located in the roofline.

The principal elevation has 4 bay openings with one door and three windows. The double, panelled door has a wooden lintel with a keystone that resembles stone. Windows are 6/6 lights with flat wooden lintels. A diamond pattern of glazed headers is placed underneath the cornice. The south elevation has 2 symmetrical bays with 6/6 windows that have flat wooden lintels. It also has diamond patterns with glazed headers. The north elevation has two bays located towards the east wall. Windows are 6/6 and 2/2 replacements. There is evidence of early segmental arches above the windows.

7.2 Description (Continued)

A large arch is also located in the basement level. The elevation has random glazed headers. The west elevation has 6/6 windows on the second floor; the rear wing extends from the first floor. The main facade of the wing faces south with three openings. Windows throughout are 1/1 replacements. The north elevation has three openings with an off-center door. The west gable end is partly stone, partly brick.

Agricultural outbuildings date from the late nineteenth century and include a drive-through corncrib, a bank barn with a ceramic tile silo and a barrel-roofed concrete block barn with an attached concrete block dairy.

The Herman Brust House, 7911 Black's Mill Road, dates from 1794. It was originally a miller's house associated with a grist mill several feet to the north (stone remains of this mill are evident). It is a 2 story running bond brick house on a stone foundation with a gable roof of standing seam tin. It has two interior end brick chimneys and a shallow brick cornice. A 2 story brick wing extends from the south elevation of the main block: it is reputed to be log encased in brick.

The principal elevation, facing north, has 4 bays with one off center door. 6/6 windows on the first floor have jack arches; on the second floor, the windows have flat wooden lintels. The west and east elevations of the main block are 2 bays wide with 6/6 windows with jack arches and 4/4 attic windows. The south elevation is covered by the rear ell. The main facade of the ell faces east with the gable roof running north to south. A two story frame attachment extends from the wing on the east elevation; it is sheathed in german siding and has a flat roof. It has 6/6 ribbons of windows on the first floor and 6/6 windows on the second floor. The west elevation has 2 symmetrical bays with 6/6 windows. The south gable end has one 4 light fixed window in the attic.

One small outbuilding is located to the south of the house. It is a one story, frame building with vertical siding and a gable roof of standing seam tin.

The Anderson House, 7815 Black's Mill Road, is a 2 story log and frame house (circa 1860) located several yards to the west of the Herman Brust House. It is sheathed in asbestos tile shingles and rests on a stone foundation. The corrugated tin gable roof has two interior end brick chimneys. A two story frame rear ell extends from the south elevation with a corrugated tin gable roof.

The principal facade faces north and has 3 bays. It has 6/6 windows and a central door. The east elevation has 2 6/6 windows on the second floor and 2 6 light attic windows. The west elevation has 1 bay opening. The rear wing has a recessed double porch on the east elevation. The south gable end is sheathed in aluminum and has no openings. The west elevation is 2 bays wide.

7.3 Description (Continued)

Outbuildings with the property include two small vertical sided sheds and a bank barn with a ceramic tile silo.

The Ward House, 8040 Black's Mill Road, dates from the early 1800s and is located on the east side of Hunting Creek, approximately 1/8 miles from the focus of the district. It is a 2 story brick house with a gable roof of asphalt shingles and rests on a stone foundation. Brickwork is flemish bond on the main (south) facade; 5:1 common bond on the other elevations. It has two interior end brick chimneys and a corbelled brick cornice. The exterior of the house reveals an interior side hall plan. A 2 story brick rear wing extends from the north elevation with a gable roof of asphalt shingling and a corbelled brick cornice. It has an interior end brick chimney and a new center brick chimney.

The principal elevation, facing south, has 3 bays with a side door opening and 6/6 windows with gauged brick arches. The door has 6 panels, a 4 light transom and recessed side panels. The east gable end has 2 attic windows with jack arches and no other openings; the west gable end has 2 symmetrical bays with 6/6 windows and 2 attic windows (all windows have jack arches). The rear ell extends from the north elevation.

The main facade of the rear ell faces east; it has a recessed open double porch, 2 bays wide. The remaining two bays are symmetrical with a door and window on the first floor and 2 windows on the second. Jack arches are above all the openings. The west elevation is 2 bays wide with 6/6 windows and 1/1 replacements. The north elevation has no openings except for 2 attic windows.

Surviving outbuildings include a german-sided chicken coop and a ceramic tile silo. There are also remains of a barn.

The Zimmerman Farm, 7610 Black's Mill Road, is located approximately 1/2 mile from the mill sites. A mill race extending from Little Hunting Creek, several yards from the farm, connected it to milling operations nearby. Built circa 1850, it is a 2 story log house sheathed in vinyl siding with a gable roof of standing seam tin. It also has two interior end brick chimneys. A one story, rectangular wing is attached to the west and south elevations; it is comprised of stone, brick and frame sections and dates from the early 1800s.

The main facade, facing east, has 5 bay openings with 1/1 replacement windows. A one story full facade open porch has turned columns and a concrete base. The south elevation has two symmetrical bays and a basement door. The one story wing covers the bay closest to the west wall. The north elevation also has two symmetrical bays. The front porch wraps around to include part of this elevation. The west elevation is covered by the wing.

The main elevation of the one story wing faces east and is exposed from deterioration. This elevation shows two rooms built in different sections: the section to the south is of stone; the one closest to the house is frame covered

in weatherboard. A center brick chimney connects the two rooms with a fireplace opening into the frame section. Two other rooms are attached to the frame section and the rear (west) of the main block. The next section is stone; the last section is one bay wide and is of brick construction. The west elevation of the main house section has a catslide roofline and 6/6 windows: there is board and batten siding on the frame section, stone and brick on the others. The interior of this wing shows the progression of the rooms. There is beaded wallboard, a boxed staircase and rubble nogging.

Outbuildings include three german-sided sheds and a gambrel roofed concrete block dairy barn dating from the early twentieth century.

8.1 Significance:

The Black's Mill District represents an early industrial community that operated from the late eighteenth century through the nineteenth century. Buildings in the district related to the milling industry as residences or nearby farms. Although the industrial structures are no longer extant, the remaining buildings give evidence of a former community centered around Hunting Creek and the mills. By the nineteenth century, it had developed into a crossroads location on the route to larger villages like Creagerstown and Thurmont. Architecturally, the surviving resources were constructed from the late eighteenth century to the mid-nineteenth century. The majority of the buildings are of brick construction with a sophisticated level of design and plan. The other buildings are of log construction typical of the region.

Many mill communities probably flourished in Frederick County during the eighteenth and nineteenth centuries. Today, few of those communities have survived. One such community, Kinna's Mill District (F-6-50), has an intact assemblage of eighteenth and nineteenth century resources including the original mill structure which exemplifies the development of a mill community in the county. By comparison, Black's Mill District shows a more limited period of development and has lost its industrial structures. However, remaining buildings in the district clearly demonstrate the significance of the community as an important focal point of the region from circa 1775-1885.

The Creagerstown area was the earliest region settled in Frederick County in the early 1700s. Most of the settlers were of German descent. The establishment of milling operations in coordination with farming activities probably began by the mid-eighteenth century. By 1808, the Varles Map indicates several mills located in the region including two grist mills on Hunting Creek in the Black's Mill District. The Castle House, the Herman Brust House and the Zimmerman Farm had been constructed by this time. In 1858, a merchant and saw mill was operated by Samuel Diffendall; the water rights had been transferred to him in 1856 (Land deed, E.S. 9, 67). A merchant and saw mill was a commercial and industrial enterprise where cash was paid for crops suggesting a money economy. The presence of that type of mill indicated economic prosperity in the immediate area. (Interview with John McGrain, Maryland mill historian, 4/91) By 1873, a merchant grist mill and a saw mill were still functioning. The district had developed to include all of its present day buildings by this period and experienced prosperity through its industrial and agricultural pursuits.

The level of architectural design also suggests that the district prospered from the late eighteenth century. Two brick buildings, in particular, show evidence of high style architectural influence. The Castle House demonstrates features of the Georgian and Federal periods with a beltcourse, glazed header patterns, a watertable, flemish bond brickwork and elegant entrance. The Ward House also has elements of the Federal style particularly noted in the side hall plan, the flemish bond brickwork and the gauged brick arched lintels.

8.2 Significance (Continued)

Later buildings in the district reflect vernacular, regional architecture seen in the log dwellings and the main brick section in the Herman Brust House with the 4 bay facade.

A number of families were associated with the district. The earliest known owner of the Castle House was James Johnson who sold "buildings and water courses" in 1817 to James Walker (Land deeds). The property was owned by the Zimmermans in the early to mid 1800s. It became known as "Highland Farm" and had a 265 acre tract. Daniel Castle purchased the property in 1856 and it remained in the Castle family until 1943. The Herman Brust House was a miller's house. In 1858, F.R. Wilson resided there; by 1873, George W. Shaw was the owner. Shaw sold the property in 1880 to the Black family (present day name of the area). The Blacks owned at least one of the mills and the house until 1914 when the Mayn family purchased it. The Zimmermans were associated with the district by the early 1800s. In 1858, M. Zimmerman owned the Zimmerman Farm. By 1873, he also owned the Anderson House and another building no longer standing in the district.

Remains of a mill and at least one mill site are significant aspects of the district. The location of the mill races are evident near Hunting Creek and near the Zimmerman Farm at Little Hunting Creek.


Further analysis and documentary research should be undertaken in this district as it represents a eighteenth century milling community.






