The Creamery Road House is located on Creamery Road approximately two miles from the town of Emmitsburg, Maryland. The principal elevation faces east with the gable roofline running north to south. It otherwise typifies a small mid-nineteenth century farmstead in the region. It can be associated in historic context with a nearby mill complex that dates from the eighteenth century.

7.1 Description:

The Creamery Road House is located on Creamery Road approximately two miles from the town of Emmitsburg, Maryland. The principal elevation faces east with the gable roofline running north to south. A small bank barn and a tractor shed accompany the dwelling house.

Constructed circa 1840, the 2 story house is of brick and stone construction resting on a stone foundation. The east and north elevations are composed of 6:1 common bond brick; the west and south, stone. The gable roof of composition shingling has two interior end brick chimneys.

The main (east) elevation has a 4 bay facade. Two panelled center doors have 3 light transoms and corner block lintels. Windows are 6/6 with corner block lintels. A one story open porch covered by a corrugated tin hipped roof runs the full facade and has square columns with brackets. On the south end, stone quins into the brick. The north elevation (also brick) is 2 symmetrical bays wide. Windows are 6/6 with corner block lintels on the first and second floors; the attic has two 2/2 lights; the foundation has two windows with jack arches.

The west elevation is 4 bays wide with 2 center doors; one filled in, one with a transom light. Windows are 6/6 with corner block lintels, assymetrically placed. A one story flat-roofed open porch extends across the facade with a balustrade and chamfered columns. On the north end, brick works into the stone. The south elevation is 2 symmetrical bays wide with 6/6 windows with corner block lintels and two 2/2 attic windows.

A small bank barn with a brick foundation and vertical siding is located to the west of the house. It is decorated with rounded arched louvred vent windows. A small tractor shed is located several feet from the barn and is vertical sided.

8.1 Significance:

The Creamery Road House provides an unusual example of the two story 4 bay house with a combination of stone and brick elevations. It otherwise typifies a small mid-nineteenth century farmstead in the region. It can be associated in historic context with a nearby mill complex that dates from the eighteenth century.

Compared to other houses of its type, the Creamery Road House retains a high level of integrity. Accompanying outbuildings have dwindled to a bank barn and tractor shed, but it still has an appearance of a farmstead. Although there are many two story, 4 bay houses intact in Frederick County, this is one of the only examples showing an unusual combination of construction materials (brick and stone).

The property was owned by H. Dotterer in 1858 and J. Stambaugh in 1873. Dotterer was a member of a prosperous family of German descent in the region engaged in farming and milling. The farm is located within 1/8 miles of a eighteenth century milling complex on Toms Creek which greatly contributes to the historic context of the farm. The saw and grist mills are no longer standing; however, an eighteenth century miller's house (2 story brick with a one story brick wing) survives (Anthony James Survey, Form VI,106).




