The Motter's Station Survey District is clustered around the intersection of Four Points Road and Motter's Station Road in the vicinity of Emmitsburg, Maryland. The district is comprised of eight contributing buildings and three non-contributing buildings. The survey district is significant in representing a railroad community on the Emmitsburg rail line. Dating from the late nineteenth century, the district demonstrates a commercial cluster around a rail station with accompanying residences and shows a homogenous architectural character: four of the residences were constructed in the same house type, the I-house. The simple, vernacular buildings of the district reveal the utilitarian nature of a railroad station district. The district is no longer associated with the railroad, and the commercial buildings are not in use.

7.1 Description:

The Motter's Station Survey District is clustered around the intersection of Four Points Road and Motter's Station Road in the vicinity of Rocky Ridge, Maryland. The district is comprised of eight contributing buildings and three non-contributing buildings. It developed in the last quarter of the nineteenth century as a station on the Emmitsburg Railroad line. It includes representative commercial and residential buildings dating from that period and associated with the railroad industry. Today, the district is chiefly residential with no commercial activity.

The district is homogenous in character. Four of the residences are 2 story, 3 bay I-houses. A complex of three commercial buildings, located where the railroad tracks formerly ran, are similar in form and type with the principal building serving a warehouse function. Buildings in the district were influenced by vernacular designs, commonly seen in railroad districts.

A commercial complex affiliated with the railroad is situated at the corner of Four Points Road and Motter's Station Road. Facing south, the complex dates from circa 1890. It includes a three sectioned building: the first section is a one story gable-front building that is sheathed in asphalt shingling. It has a standing seam tin gable roof. One 6/6 window is placed beneath the gable peak. The storefront is covered with an open, full-facade porch with round columns and a shed roof of standing seam tin. The storefront is sheathed in german siding. This section is attached to a one story concrete block building with a flat roof. It has a frame sliding door. The third section is on the east side of the concrete block section: it is a gable-front building sheathed in corrugated metal with a standing seam metal gable roof. There are 6/6 windows beneath the gable peak and in the first floor. There is a side door on the first floor with a shed roofed porch entry.

Separate from the three sectioned building to the east is a one story gable-front concrete building with a recessed two bay center. It has german siding in the gable. The main elevation has a 1/1 window, 2 picture windows, and a 2 part door.

Another commercial building is located on the southeast corner of the intersection. It is a one story concrete block building with a slight parapet roofline. It has 6/6 windows and garage doors. It probably served as an early twentieth century garage.

Residential buildings include the following:

15527 Motter's Station Road: This two story, 3 bay frame I-house faces south and dates circa 1890. It is sheathed in aluminum siding. The gable roof of standing seam tin has one interior end brick chimney. It has a hipped roof open porch and 2/2 windows on the main elevation. A garage is located to the rear (north).

15529 Motter's Station Road: Constructed circa 1890, this two story, 3 bay frame I-house is sheathed in aluminum siding. It has a gable roof with

composition shingling and one exterior end brick chimney. The main elevation faces south. A 2 story rear ell extends off the north elevation. Windows are 6/6. Outbuildings include a barn and a small shed.

15507 Motter's Station Road: Situated several feet from the railroad commercial buildings, this is a 2 story, 3 bay frame I-house, sheathed in aluminum siding and dating circa 1890. The gable roof of standing seam tin has one interior end brick chimney and one exterior end brick chimney. A 2 story ell extends to the side. The main elevation, facing south, has 2/2 windows with classical surrounds and a center door with a transom. Three outbuildings are located to the north of the house including a one story stone outbuilding.

15429 Motter's Station Road: Constructed circa 1920, this one and one-half story brick bungalow is located next to the twentieth century garage and faces west. It has 3/1 windows and a gabled dormer.

15405 Motter's Station Road: Several yards south of the bungalow, this two story 3 bay frame I-house (circa 1890) is sheathed in asphalt shingling. It has a 2 story rear ell. The main elevation, facing west, has 1/1 (replaced) windows and a entry hood with a hipped roof and bracketed columns. A small cluster of eight domestic outbuildings includes a small vertical sided barn.

Non-contributing buildings in the survey district are 15525 and 15517 Motter's Station Road, both ranchers, and 15512 Motter's Station Road, a Cape Cod.

8.1 Significance:

The Motter's Station Survey District is significant in representing a railroad community on the Emmitsburg rail line. Dating from the late nineteenth century, the district demonstrates a commercial cluster around a rail station with accompanying residences and shows a homogenous architectural character: four of the residences were constructed in the same house type, the I-house. The simple, vernacular buildings of the district reveal the utilitarian nature of a railroad station district. The district is no longer associated with the railroad, and the commercial buildings are not in use.

This district can be compared to other railroad districts in the county such as the Lantz Survey District (F-6-51) and the Loys Survey District (F-6-69). Unlike Loys and Lantz, Motter's Station no longer has the railroad running through the district which has altered its historic setting. It is most similar to Lantz with its scaled-down buildings that were primarily functional with minimal excess. Despite the alteration of historic setting, the buildings in the district have retained a good degree of integrity.

The Emmitsburg Railroad was in operation from 1875 until post 1910. The rail line was 7 miles and was owned by local residents who subscribed to it. It connected Emmitsburg and outlying areas to the Western Maryland Railroad and became important to the economy of the area. The survey district developed after 1875; by 1887, the population of Motter's Station was 20. It continued to grow into the early twentieth century.








RESOURCE SKETCH MAP



