The George W. Horman House is a two-story frame dwelling with Queen Anne style influences built about 1901 and possibly altered later in the first or second quarter of the 20th century. Its outbuildings include a stone garage of about 1901 and, located on the opposite side of Roderick Road from the house and garage, a concrete block dairy barn, milk house, silo, and a brick dairy, dating from about 1925 to 1935. The house has vinyl siding and a pressed metal roof and is distinguished by a corner polygonal turret and a veranda on the east and north elevations. Palladian-influenced windows in the east and north elevations are characteristic of the Queen Anne style. The former agricultural outbuildings are functional in design and materials and are typical of their period. The brick dairy was used as the processing and bottling plant for the Tip Top Dairy, operated by George W. Horman's sons during the period about 1925 to 1940. It has a stepped parapet with a three-bay main elevation. The modern door and windows reflect its current use as an office or guest house for the property at 3301 Roderick Road.

The George W. Horman House and Outbuildings consist of a two-story frame dwelling with Queen Anne style details built about 1901 and four contributing outbuildings which include a circa 1901 stone garage on the same parcel as the dwelling and, on a separate parcel, a brick one-story dairy, a concrete block dairy barn, milk house, and silo, all dating from about 1920 to 1935. The dwelling and garage are located on the west side of Roderick Road and the dairy, the barn, and the other formerly agricultural outbuildings are on the east side of the road. The former farmstead is currently part of a subdivision called Urbana Overlook located on the south side of Fingerboard Road about 3/4 mile west of Urbana, Frederick County, Maryland. The former open fields surrounding the old farmstead are now divided into separate parcels and several modern residences are located on Roderick Road north and south of the farmstead's remaining buildings. Dates of the buildings are based on land records, architectural details, a biographical sketch of George W. Horman in the 1910 History of Frederick County, and a personal interview with Mr. Marion Lawson, whose family formerly owned an adjoining farm.

The Horman dwelling house is a frame structure with irregularly massed exterior features and a varied roofline. The principal east elevation has a center projecting bay flanked by two bays on each side. On the north side of the center cross gable, the roof is hipped in outline, and terminates at the northeast corner in a polygonal turret with a faceted pressed metal roof. On the south side of the cross gable, the roofline is an extended gable, suggesting that the roofline was altered at some date in the early 20th century. The exterior is covered with vinyl siding and the entire roof is pressed metal, covering any possible evidence of a building sequence. An interior chimney rises above the roof near the junction of the eastern cross gable and the main roof ridge. The windows on the second story are 1/1 modern replacements, while those on the first story are 2/2. In the projecting central bay are two subsidiary bays, one of which contains the main door on the first story, a simple paneled door with a glazed upper section. In the gable peak is a Palladian-influenced, three-part window with an arched center opening. The two bays of the cross gable are sheltered under a metal-roofed porch which extends across the north end of the east elevation and across all of the north elevation to form a veranda. The posts are square-cut and are probably replacements. Also on the north elevation is another cross gable with the same Palladian type window as on the east elevation. A side door of the same type as on the east elevation is also on the north elevation. The south elevation of the house has a one-story side porch with an enclosed section at the southwest corner. The interior of the house was inaccessible for this survey.

Garage: The one-story stone garage is a gable-roofed building just south of the dwelling. It has a corrugated metal roof and vertical tongue-and-groove gables on the east and west. The walls are fieldstone and the north side was apparently open or had sliding doors in its original condition. The north side now has two turned columns, possibly formerly installed on the porch of the dwelling standing in antis before an enclosure of plywood. A former opening on the east elevation is boarded. The garage was built in the early 20th century, according to Mr. Lawson.

The George W. Horman House and Outbuildings are minimally significant in agriculture and architecture as examples of an early 20th century Queen Anne style dwelling with modern exterior alterations and of the basic dairy farm outbuildings, consisting of a milking barn, a silo, a milk house, and a dairy processing and bottling building, used in the first and second quarters of the 20th century. The house was built about 1901 by Horman (1869-1951), according to Williams & McKinsey's 1910 History of Frederick County. Horman and his sons Russell, George, and William ran a thriving dairy farm in the first half of the 20th century and sold their milk under the name "Tip Top Dairy". The sons peddled the milk and other dairy products to stores over much of Frederick County, bottling in the brick dairy building still extant near the dwelling, but now on a separate parcel. The concrete block dairy barn, milk house, and silo are typical representatives of their types.


7.1 Description (Continued)

Dairy barn, milk house, silo, and brick dairy: Located on the east side of Roderick Road directly opposite the dwelling and the garage are the remaining agricultural buildings associated with the Horman farm. The concrete block dairy barn and silo with the adjacent concrete block milk house appear to have been built in the mid-1920's. The barn has a gambrel roof and wood sided gables. The one-story brick building just north of the barn was identified by Mr. Lawson as the dairy building where the farm's milk products were bottled under the name "Tip Top Dairy" by Russell Horman, a son of George W. Horman. It has a stepped parapet on the west elevation and three bays with a center entrance flanked by 1/1 replacement windows. The door is also a modern metal replacement. The roof is standing seam metal with an off-center interior brick chimney near the middle north side. The west gable end has a small window in the gable peak and bears traces of whitewash on the brick above the south bay. The building is currently used as an office or guest house. All of the former Horman agricultural buildings on the east side of the road are currently on Parcel 205, Lot 11, owned by Weldon P. Kennedy, 3301 Roderick Road, Frederick, MD 21701.
