The Green Oak School is a fair example of an early 20th century frame rural schoolhouse, having the same appearance and plan of late 19th century schools, with a gable facade, a one-room plan, and german siding. The schoolhouse, built about 1904, also has a stone foundation and a recessed, double-door entrance with a paneled soffit. A broken pediment surround was added after its conversion to a residence about 1918. At that time, a 1-1/2 story frame addition was erected on the east gable end. It also has german siding and the 3/3 sash are in casement style. The school was active only about 14 years, closing about 1918, when consolidation with Urbana took place. It is unusual among former schools which have been converted to residential use in that its single room plan is still intact, with separate cloakrooms flanking the entrance door, a high ceiling, and a tongue-and-groove wainscot.

CONTRIBUTING RESOURCE COUNT: 1

The Green Oak School is a one-story frame building erected about 1904 on the northeast corner of Urbana Pike and Price Road about two miles south of Urbana, Frederick County, Maryland. The building's original one-room plan remains intact, although a 1-1/2 story frame addition was built on the east gable end about 1918-1920 when the schoolhouse was converted to a residence. The three-bay original facade faces west and the exterior is covered with german siding. The date of the building was estimated by architectural details and land records.

The gable roof of the schoolhouse is covered with corrugated metal and the foundation is stone. The west elevation has a center entrance with double doors with two raised panels in each door. A five-light transom is above the doors and a paneled recessed soffit surrounds the doorway. A Georgian style door surround with fluted pilasters and a flat plywood facsimile of a broken pediment and a half-round central urn was probably added when the building was converted to residential use. A concrete porch platform with pipe railings may have been in place by 1918. Above the doorway in the west gable is a single window opening with 1/1 sash. This opening probably had 6/6 sash originally. The north and south elevations of the schoolhouse had three bays with 6/6 sash. The 1-1/2 story addition, which also has german siding, has irregular bays with 3/3 windows in casement style. Entrances with bracketed hoods are located on the north and south elevations of the addition. A one-story shed extension is on the east end of the circa 1918 section. An exterior concrete block chimney is located on the north elevation and an off-center interior brick chimney rises from the wall junction between the schoolhouse and the addition.

The interior of the original schoolhouse retains its original plan, with a single room fronted by small cloakrooms flanking the western entrance. The ceiling is high and the walls have a tongue-and-groove paneled wainscot below plaster walls. At the east end of the room, where the teacher's desk was probably located, a brick fireplace has been added.

The Green Oak School is a fair example of an early 19th century schoolhouse, built about 1904 according to land records, in the simple, one-room style of late 19th century rural schools in Frederick County. It is somewhat unusual in the context of the surviving schoolhouses of the County which have been converted to residences in that its original plan is intact, without partition walls obscuring the single space of the interior. The school was short-lived, closing in about 1918 when consolidation with Urbana took place. The name of the school was supplied by Mr. Marion Lawson, a live-long Urbana resident, but existing county directories, which list other schools by name, are not available for the approximately 14-year period of the school's operation. According to Mr. Lawson, the subsequent owner of the building, Bradley Dudrow, added the residential section.


