DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Hampton School is a one story medium hipped roofed rectangular common bond brick building which faces south from the north side of Route 80 at the intersection with Park Mills Road. The building is unrelated to any other buildings.

The principal facade is three bays wide, the main entrance, twin doors with five horizontal panels and three light transom is located in the second bay. The door is recessed in an arched doorway with radiating voussoirs below a tower which extends forward of the front plane of the building. The tower is hipped roofed with a boxed cornice, plain frieze and twin louvered vents on each side. A stone plaque over the door states "Hampton School No. 7.. District No. 8 1908". Occupying the remaining two bays are double hung 4/4 windows with brick arches of radiating voussoirs. A tin medium hipped roof is finished by a boxed cornice with plain frieze; the entire building is constructed on a low random stone foundation.

The east and west sides of the building are identical. Each is four bays wide with a double hung 4/4 window with brick arches of radiating voussoirs.

A storm cellar entrance is located below the first bay on the east side from the southeast corner. A frame shed porch addition extends from the north side of the building. The northwest corner is clapboard with a double hung 6/6 window. The remaining porch is vertical plank with twelve pane windows in the top half. A four panel entrance door leads into the porch east of the center of the building.

A single corbeled inside brick chimney is located on the north side of the building.

An operable pump is on the east side of the building.

The school is generally in a fair state of repair.


