The two-story frame house was built about 1885-1900, probably by George Montgomery, the 1885 purchaser of a larger farm property which had been in the Montgomery family since the late 18th century. The house is a vernacular, German-influenced type that is commonly built in the late 19th century throughout Frederick County. It has German siding and a slate roof, a one-story porch, and a two-story rear wing with an enclosed two-story porch on the east side. Two deteriorated frame agricultural outbuildings, a wagon shed/corn crib and a shed, are also associated with the house. The property is still owned by a Montgomery descendant.

The George Montgomery Tenant House is a two-story frame dwelling built about 1885-1900 on the north side of Ball Road about two miles north of Urbana, Frederick County, Maryland. Two contributing agricultural outbuildings are associated with the house, a frame wagon shed/corn crib and a frame shed, both in deteriorated condition. A non-contributing concrete block smokehouse is also in the building group. The house and outbuildings are a tenant property historically associated with the Montgomery farm at 9120 Ball Road. Dates of the buildings in the tenant building group are based on architectural details and historical maps.

The dwelling is located on a hill rising above the road with its principal elevation facing south. The facade has three bays on the first story and two on the second. German siding covers the exterior and the roof is slate. An interior end chimney is on the west gable end. A one-story porch with a concrete block base and deck extends across the south elevation. A two-story rear wing projects from the northeast corner of the house. The windows are 2/2 with louvred shutters. The center entry has a glazed panel door. The gable ends have a single bay on each story. The wing has a one-story porch on the west side. Part of the rear wing on the east is covered with vertical board siding, suggesting the probability of an enclosure of an original two-story porch. A one-story shed addition adjoins the enclosed porch on the east side. An interior chimney is at the junction between the wing and the main section. The roof of the wing is covered with composition material. The interior of the house was inaccessible for this survey.

Wagon shed/corn crib: The frame wagon shed/corn crib is in deteriorated condition. It appears to have been built about the same period as the house, approximately 1885-1900. It has vertical siding and stone piers support the cribs on the sides. The passage is off-center, and the east side crib is larger than the west, a feature suggesting that two types of grain were stored in the bins. Other granary sheds of this type usually held wheat in the larger crib and corn in the smaller one. The west side crib has vented horizontal siding and the eastern crib has flush vertical siding, which supports the dual granary use. The roof is corrugated metal.

Shed: The frame agricultural shed is located north of the wagon shed and is also in deteriorated condition. It has vertical siding and a corrugated metal roof. An opening on the north gable end is the only access to the interior. The shed is currently in use as a cow shed.

The George Montgomery Tenant House is minimally significant for its architecture, a vernacular style based on German building traditions of the 18th and 19th century. The house was probably built about 1885-1900, based on its absence from the 1873 Titus Atlas map. The larger farm property on which it is located has been owned by the Montgomery family since the late 18th century, although its acreage and boundary outlines changed with several transactions throughout the 19th century and the section on which the tenant house is located may be part of a later purchase. In 1885, George W. Montgomery received a portion of the property as a result of an equity sale and it is probable that the tenant house was erected by him after this purchase.


