The Elijah Price House is a fair example of the vernacular Italianate style, having a wide cross gable, dentil molding, arched decorative windows in the gables, and a central hall plan with two rooms on each side. The house was probably built about 1850 by Elijah Price, whose son George W. Price (1840-1918) purchased it in 1874. The brick house also has double interior chimneys on the gable ends and a one-story porch on the main elevation. The windows have flat wood lintels and 1/1 replacement sash. The original sash was probably 2/2. In comparison with more elaborate examples of the Italianate style, the Price House is restrained in decoration and features.

CONTRIBUTING RESOURCE COUNT: 1

The Elijah Price House is a two-story brick dwelling with Italianate details erected about 1850 on the east side of Green Valley Road (Md. 75) about 1/2 mile northeast of the intersection of Lewisdale Road in Frederick County, Maryland. The nearest town is Hyattstown in Montgomery County to the southeast. The house is at the end of a driveway about 2,000 feet from Green Valley Road and was formerly the principal residence of a large farm which has been subdivided in recent years into individual residential lots and developments. These are located along Green Valley Road and around the Price House across the remaining open fields surrounding the house and the still-active agricultural buildings located east of the house. The non-contributing agricultural buildings are now on a separate parcel. The house's principal elevation faces west. The date of the structure is based on land records, historical maps, and architectural evidence.

The dwelling has a five-bay principal elevation and is four bays deep, indicating that its interior plan is probably a center hall type with two rooms on each side. The interior was inaccessible for this survey. The exterior walls are laid in stretcher bond with narrow flat wood lintels above the 1/1 windows. The main elevation has a broad center cross gable with a round-arched 1/1 window. The arch is outlined with voussoir brick. Star tie rod plates are located on the gab' wall just above the second floor level. The cornice around the entire house has dentil trim. The roof has a composition covering and double interior chimneys at the gable ends. The west elevation is crossed by a one-story flat-roofed porch with a concrete block base. The chamfered porch columns are on brick bases and have simple brackets. The center doorway has a transom and sidelights with a molded 4-panel door. On the north elevation are two irregular bays. The south elevation has four window bays and a central arched gable window with a voussoir arch. The window is 2/2, possibly indicating the original fenestration of the other windows, which now have 1/1 replacements. The east elevation has a two-story frame addition covered with vinyl siding. A one-story shed-roofed replacement porch extends across the rear and southwest side of the addition. The doors and windows in the addition are modern, and its date of construction is not clear.

A non-contributing concrete block meathouse is located just behind the house. It has a german-sided gable and a tongue-and-groove door in the southwest elevation. Its date is unknown.

The Elijah Price House is a fair example of a vernacular Italianate dwelling of the period about 1850. Its ample proportions, cross gable, attic level arched windows, dentil molding, and double chimneys are characteristic of the style, but, in comparison with more elaborate Italianate houses of the same period, it is subdued in general appearance. The house was built probably by Elijah Price, whose name appears on the 1858 Bond map. In 1874, his son George W. Price (1840-1918) purchased the approximately 239-acre farm which by that date covered lands in both Frederick and Montgomery Counties. His descendants retained the farm until 1949. Over the course of the second half of the 19th and most of the 20th century, the historical outbuildings which formed the farmstead have been removed, leaving only a placement meathouse near the residence and a non-contributing group of agricultural buildings which are now on a separate parcel east of the house.




