The Wayman A.M.E. Church is a one-story frame hall-type church built about 1868 on the south side of Old Liberty Road. Its single distinguishing architectural feature is the apsidal west end added in the 1880's along with a pulpit. Wayman A.M.E. Church and the nearby Silver Hill M.E. Church (F-8-124) are good examples of rural African-American churches of the late 19th century. Further research on the churches' histories and interior details is needed to define the context of black rural churches in the last quarter of the 19th century.

7.1 Description

The Wayman A.M.E. Church is a one-story frame building erected about 1868 with a rectangular plan and a gable roof located on the south side of Old Liberty Road near Mt. Pleasant, Maryland. The site is on a small hill overlooking the present Liberty Road (MD Rt. 26) which passes to the south of the church. The building has an apsidal west end added in the 1880's along with a pulpit in the interior. The entrance is in the east elevation. The exterior is covered with composition siding over weatherboards and has a stone foundation. The roof is standing seam metal. The entrance has double unpaneled doors. No architraves are visible. The north and south elevations have four bays each with 1/1 sliding sash with colored glass. The interior was not accessible for this survey; however, Mrs. Gladys Cooper, a long-time member, states that the walls are painted plaster with light fixtures hanging from a flat ceiling. A modern stained glass panel is backlighted behind the pulpit. The floor is pine over the original floorboards. Four of the original hand-made pews are still in use in the choir section. The pulpit which brought about the 1880's expansion was replaced with a modern structure in recent years.

North of the church is a cemetery with burials dating from the 1860's which is shared with the Silver Hill Methodist Episcopal Church (F-8-124). The Silver Hill Church, built about 1875, is located on a separate parcel at the north end of the cemetery just off Old Liberty Road.

8.1 Significance


The Wayman A.M.E. Church is a good illustration of the small rural African-American Church of the post-Civil War period of the 19th century. Built for a congregation of freed slaves according to church tradition, the church is near a second African-American church, the Silver Hill M.E. Church, built about 1875. The connection between the two congregations has not yet been researched; however, the close proximity of the two churches is reasonable given the lack of church sites available to black congregations after the Civil War.

The 1858 Bond Map shows a Methodist Episcopal Church at approximately the location of the two churches. Mrs. Cooper stated that traditionally the Silver Hill Church was thought to be older than the Wayman Church, but this is not supported by the available deed references. It is possibly an earlier church building built prior to 1858 or the existing structure of the Silver Hill Church, for which a formal deed was not recorded until 1875 after the construction of the Wayman Church.

Wayman was named for Bishop Wayman, the first bishop under whose jurisdiction the church was established. It was part of a three-church charge including St. Paul's at Della in southern Frederick County, and St. James at Bartonsville. Wayman and St. Paul's remain in the charge; St. James is no longer a member.


