DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Calvin Thomas Store is a one story rectangular brick commercial structure laid in common bond with boom style front stepped gable which faces north from the south side of Route 26 in Mount Pleasant.

The main facade is three bays wide. The principal entrance, a replaced four panel door is located in the second bay. Wood pegs which held the sign over the door are still intact. The dimensions of the entrance have been altered.

Occupying the remaining bays are original double hung 6/6 windows with flat brick arches. Another double hung 6/6 window is located on the east and west elevations of the building.

The entire structure is covered by a corrugated tin roof attached to the building by a corbeled brick cornice.

The building is constructed on a low random stone foundation. A single brick chimney rises from the southeast corner of the building.


