The J. Snyder House was built prior to 1858 as indicated by the Bond Map of the area showing a residence in the existing location and a second building at the Kelly Road intersection with McKaig Road which is no longer standing.

The building is particularly architecturally significant for its Carpenter Gothic styling including decorative pierced frieze, dropped pendants, bargeboard trim, arched panel doorway and patterned slate roof. The house has also retained its outbuildings including a log outbuilding with wood shingling wagon shed and small bank barn which has retained its decorative bargeboard.

The property became part of a subdivision in the early 1970's but was left intact as a small farmstead.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The J. Snyder House is a two and one-half story cross gabled Carpenter Gothic frame ell shaped residence which faces south from the north side of Kelly Road.

The principal facade is three bays wide. The main entrance, an arched four panel door set into a paneled doorway with single light transom, is located in the second bay.

Occupying the remaining bays on the first and second levels are original double hung 2/2 windows with louvered shutters. A small four pane Victorian Gothic window is located in the front gable.

A one story frame porch with standing seam tin hipped roof extends across the front of the building three bays wide on the first level. The roof is supported by six original turned wood columns with a boxed cornice with decorative pierced frieze, scrolls and dropped pendants. The porch has a wood tongue and groove floor and is supported by brick piers.

The main block of the building is two bays deep with original double hung 2/2 windows occupying each bay on both levels in the east and west gable ends. Two "half" Victorian Gothic windows are located in the east and west gable ends of the building.

An original two story rear addition extends two bays deep in the rear of the building.

A two story open porch with plain wood columns and railing extends along the entire east side of the rear addition. A four panel door with one light transom enters on to the porch in the first bay on each level. Original double hung 6/6 windows occupy the remaining bays on each level.

A one story modern frame addition has been added to the northwest corner of the building.

The residence is entirely covered by German or novelty siding with corner boards. The cross gable roof is original and is covered with patterned slate in fishscale design. Three painted single corbeled brick chimneys rise from the center in the east, west and north gable ends.

A boxed cornice with return encompasses the building and is ornately decorated by a pierced bargeboard with dropped pendant in each gable and a cut out frieze in star shaped design.

The entire building is constructed on a low whitewashed random stone foundation.

The building is surrounded by a whitewashed log outbuilding with shake shingle roof, wagon shed and small frame bank barn with decorative bargeboard.


