According to the 1858 Bond Map, the house was occupied by J. Cramer. In 1859 the house was sold as part of John Newport's estate to Jacob Diller.

Diller owned the property until 1882 when it was sold to Daniel J. Houck. Apparently Houck died in 1885, and the land was divided between his heirs.

In 1886 Adam Nusbaum purchased the house and owned it until 1901 when the Crum family assumed ownership.

The Crum family owned the stone house and farm until 1966 when it was sold to the present owners.

The house is unusual in that it more closely resembles the stone construction south of Mount Pleasant near New Market than its immediate vicinity.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Walter Crum House is a two and one-half story rubble stone ell shaped gable roofed residence which faces west from the west side of Crum Road near Mount Pleasant.

The principal facade is five bays wide. A replaced paneled door located within an original pinned recessed paneled wood frame with four light transom is situated in the third bay. A replaced pedimented porch surrounds the main entrance.

Occupying the remaining bays on the first and second levels are double hung 6/6 windows. On the first level the windows have painted wood lintels. On the second level the windows have narrow two stone lintels. New and old panes are located in the windows. Louvered shutters flank the windows on the entire building. Stone quoins are located in each corner of the building.

A later two story rubble stone addition extends to the rear of the main block of the building.

A one story turned columned frame porch three bays wide extends between the main block and the rear addition accommodating a side entrance located in the second bay of the addition.

A two story open frame porch is located on the south side of the rear addition. A straight railing is located on the second level of the porch. For some unknown reason the south side of the second level of the rear addition is faced in brick which has been sandblasted.

The interior of the building has been modernized, although the principal rooms on the first level have retained their original Federal style mantelpieces.

The residence is built on a random stone foundation and is covered by a standing seam tin roof. Replaced brick chimneys rise from the north, side, and east gable ends.


