"The Homeplace", a two and a half story stone and log structure was built in the 1840's by John W. Burton. It remained in the Burton family until 1845 when it was purchased by Oliver D. Lease. The Sheetenhelm family who are primarily associated with the structure purchased the property in 1874. It remained in the Sheetenhelm family until 1977.

The structure was built in two separate sections. The original section was constructed of coursed rubble stone with stone quoins on the east and west ends of the wing. The second wing constructed of log covered with asbestos siding, was constructed at a later date. The principal facade of the structure is five bays wide with main entrances in the first and fourth bays. Occupying the remaining bays are original 6/6 windows crowned by plain wooden lintels in the stone section. A standing seam tin roof covers the structure. A five bay entrance porch spans the facade of the structure supported by plain wooden columns and covered by a standing seam tin roof.

The Homeplace is significant as an early structure in the McKaig area. The significance of the house also rests with its association with the Sheetenhelm family who have lived in the area since 1790.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

"The Homeplace", a two and a half story stone and log structure, is situated on the south side of Gas House Pike facing east.

The structure was built in two separate sections, the oldest section being the stone section. The principal facade of the structure is five bays wide. Occupying the first and fourth bays of the structure are the main entrances which consist of replacement doors set in recessed doorways. Occupying the remaining bays are original 6/6 windows crowned by plain wooden lintels in the stone section of the residence.

A five bay entrance porch spans the facade of the structure. It is supported by plain wooden columns and covered by a standing seam tin roof. Beneath the roof is a plain boxed cornice.

The entire structure is covered by a standing seam tin roof. A single central chimney rises from the structure. The structure rests on a stone rubble foundation.

The stone section of the structure is constructed of coursed rubble stone with stone quoins on the east and west sides of the southern wing. The log section of the structure is covered with asbestos siding. A one story frame addition extends from the rear of the stone structure.

A frame bank barn is found to the north of the house facing southwest. The foundations are composed of coursed quarried stone. The structure is covered by a standing seam tin roof.

STATEMENT OF SIGNIFICANCE

The Homeplace, a two and a half story stone and log structure was constructed in the 1840's by John W. Burton. The property remained in the Burton family until 1845.¹ The property passed through a number of owners until it was bought by Oliver D. Lease in 1865.² Oliver Lease, the son of Daniel and Catharine Sheetenhelm Lease, was born on the family farm in 1839 and settled on the Homeplace after his marriage.³ The property remained in the Lease family until 1874 when it was purchased by George William Sheetenhelm.⁴ The property remained in the Sheetenhelm family until 1977.

The Homeplace is a significant structure in the McKaig area due to its connections with the Sheetenhelm family, a family that has lived in the immediate area since 1790. The home is an example of rural architecture built in wings to accommodate the needs of a growing family and life-style.
