Justification for decision: (Use continuation sheet if necessary and attach map)

Based on the information prepared by SHA, the Samuel Hoke House, located on the south side of MD 26, east of Ceresville, does not meet the National Register Criteria for individual listing due to lack of integrity. When inventoried in 1979, the farmstead included the two story stone house and numerous domestic and agricultural outbuildings dating from the early and later 19th century and strongly conveyed the sense of the 19th century farm. According to the information provided by SHA, the property was allowed to deteriorate for a number of years before acquisition by the present owners who undertook a virtual reconstruction of the house, summer kitchen, and ice house. These buildings are hardly recognizable as historic buildings. In addition, a quarried stone fence and gateway which surrounded the house has been removed.

The Samuel Hoke House, a two and a half story square shaped stone structure, is located on the south side of Route 26 facing west in the village of Ceresville. The principal facade is three bays wide. Occupying the second bay is a wooden pannelled door set in a recessed pannelled doorway. The entrance is crowned by a three light transom. Occupying the remaining bays are original pegged 6/6 windows crowned by wooden lintels with corner block trim. An encircling porch spans the west and north sides of the structure. It is supported by double columns with decorative brackets set in quarried stone column bases. The porch, like the structure as a whole, is covered by a standing seam tin roof. The structure rests upon a stone rubble and quarried stone foundation. Two original brick chimneys rise from the structure.

A number of significant outbuildings are found on the property. The outbuildings to the east side of the house are all constructed of coursed quarried stone. A frame bank barn and two brick silos further add distinction to this architecturally significant house. Historically the house is significant for its association with a number of prominent Frederick County residents. Built by William E. Williams in the 1820's, the lands on which the house is situated included the Ceresville Stone Quarry, source of the native stone used in the construction of the house and outbuildings, and in a number of structures in the area.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Samuel Hoke House, a two story square shaped stone structure, is situated on the south side of Route 26 facing west in the village of Ceresville.

The principal facade is three bays wide. Occupying the second bay is a recessed panelled doorway. The entrance is crowned by a three light transom. Occupying the remaining bays are original pegged 6/6 windows. There is evidence of shutters which once framed the windows but are now missing. The windows are crowned by wooden lintels with corner block trim.

An encircling porch spans the west and north side of the structure. The porch is supported by double wooden columns with decorative brackets. The base of these columns rests in quarried stone column bases. The porch is covered by a standing seam tin roof.

The north side of the structure is three bays wide. An entrance is located in the second bay. It consists of a wooden panelled door set in a recessed panelled doorway. A 9/6 window occupies one of the remaining two bays on the first floor. All windows are original pegged windows crowned by wooden lintels with decorative corner blocks.

The structure is covered by a standing seam tin roof. Beneath the roof is found an original boxed cornice with return. It rests upon a stone rubble and quarried stone foundation. Two original brick chimneys rise from the structure, one from the north and one from the south gable end.

A number of significant outbuildings are found on the property. The outbuildings to the east side of the house are all constructed of quarried stone, coursed with quoin work trim. One stone structure, probably used as a summer kitchen or smokehouse is found to the rear of the house. It is constructed of quarried stone with a massive quarried stone chimney and covered by a standing seam tin roof. In addition to the stone outbuildings, a frame bank barn and two brick silos are the significant farm buildings.

The house is surrounded by a quarried stone fence and gateway which lend an impressive air to a significant early nineteenth century structure. The house banked against a small hill commands a view of the surrounding meadows leading to the Monocacy River.


