The Thomas Link House, a two and a half story Flemish bond and common bond laid brick ell shaped structure, is three bays wide on its principal facade. A panelled wooden door occupies the second bay, the remaining bays all occupied by replaced 2/2 windows. Original 6/6 windows are found on the east side of the structure. A three bay entrance porch spans the facade of the structure and continues around, spanning the east side as well. It is supported by plain wooden columns with decorative brackets and covered, like the structure itself, by a standing seam tin roof. The structure is laid in Flemish bond brick on the facade and common bond brick on the remainder of the structure. A brick water table spans the facade.

The significance of the Thomas Link Farm lies in its association with a number of prominent Frederick County residents and architecturally with the uncoursed stone bank barn situated on the property, one of the finest in Frederick County.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Thomas Link House, a two and a half story Flemish and common bond laid brick ell shaped structure, is situated on the south side of Stauffer Road facing south.

The principal facade is three bays wide. The main entrance occupying the second bay, consists of a panelled wooden door set in a recessed doorway. The door is crowned by a single wooden lintel. Occupying the remaining bays are replaced 2/2 windows.

Spanning the principal facade is found a three bay entrance porch which spans the east side of the structure as well. The porch is supported by plain columns with decorative brackets and covered by a standing seam tin roof.

The east side of the house is three bays wide. Occupying the three bays of the second floor are original 6/6 windows. Original 6/6 windows and an entrance are found on the first floor.

The structure is constructed of brick laid in Flemish style on the facade, and common bond on the sides. A brick water table spans the facade of the structure. A standing seam tin roof covers the structure which rests on a stone rubble foundation. Three chimneys rise from the structure, two original chimneys rise from the east and west roof ends, and one from the rear second story addition.

One of the most distinctive features of the surrounding farm on the Thomas Link House is the stone bank barn. The barn is constructed totally of uncoursed fieldstone and covered by a standing seam tin roof. Air vents are found on the north and south ends of the structure. Two original 6/6 windows are found at the base of the structure on the southern elevation.
