DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Built around 1912, the Frederick County National Bank is in the classical style. It is two full stories high with an attic story above the entablature. The main material for the building is an off-white brick laid in common bond and the trim is a light gray stone. It occupies a corner site, and its two facades will be treated separately.

The N. Market Street facade is the front of the bank and is rather narrow in comparison to the side elevation. Its main parts are two projections, with pilasters on virtually their whole face, flanking a recess in which are two columns. In the center of these columns is the entrance. The columns, and indeed the whole front of the recess, is of stone.

A stone base runs around the entire building except for the recess on this front where the entrance occurs. At its top is a projecting stone course. The pilasters on the projections have two courses of brick for a base - one course on end and one on its side. A four inch brick band runs up the sides of the pilasters forming a rectangular panel on them. The capitals are stone and have a fluting pattern on their abaci on top of which is an unusual saw tooth ornamentation resembling sharp spikes of stone, set points up. On the front of these capitals is an ornament consisting of a caduceus (wings above with two snakes coiling around a staff) with an ear of corn on either side. There are two of these with a circular disc between on each pilaster capital. The columns and bases are in the Tuscan order and their capitals are identical with those on the pilasters, but without the caduceus and disc ornamentation.

The entrance consists of a large glass panel over which is a Roman arch with the doorway proper being much smaller. The arch has a stone moulding around it made of a bead and cavetto. The keystone of the arch is a console with an eagle standing on it.

The doorway itself has a black wrought iron rail inside and a wood pediment painted black above it. The pediment is supported by consoles between which are strung garlands of leaves in three waves with scrolls of cloth hanging from the crests. On top of the pediment is another example of the saw tooth ornamentation.

Above the entrance arch is a stone moulding with a fret band motif. Over this is the recess are three windows - double hung with 1/1 sash. These are in a group and have stone surrounds with a torus moulding with foliage enrichment running across the top and halfway down the outside edge of the group.

Over the windows, the entablature occurs. It contains a stone architrave, on which, again, is the saw tooth ornament, a brick frieze, on which in the center recess, the sign is placed, and a heavy stone cornice with modillions.

In the attic story the pilasters are continued, but the recess in the center is not as deep. It contains five double hung windows with 1/1 sash on this level. There is a stone course running across the face of the entire building above these windows which serves as their lintels. Over this stone course is another stone moulding above which is the parapet of brick and a stone parapet cap. Above all is a flat roof.

The Patrick Street facade on the bank consists of five bays separated by pilasters. These pilasters have the same type bases and capitals as those on the front, but are narrower, and consequently, their capitals have only one of the caduceus and corn ear ornaments. The pilasters continue up into the attic story after being interrupted by the entablature.

The same type stone base runs around the building at sidewalk level as on Market Street and has basement windows - one to a bay - with iron bars over them.

On the first story level, four of the bays have windows with Roman arched heads and fixed sash. Brick arches are over the openings with stone consoles for keystones. The last bay to the west contains a doorway on the first floor level. This doorway is covered

by a heavy stone pediment supported by brackets made in an artificial leaf design. These brackets terminate on the bottom with a motif of inverted keystones - two smaller ones flanking a large one in the center.

Under the second story windows runs a fret band moulding between pilasters. The bays each have one window which is double hung with 1/1 sash and has stone surrounds with a torus moulding identical to that over the second story windows on the Market Street elevation.

The attic story on this facade is essentially the same as on the front. There are two windows in each bay and their lintels and the mouldings over them, and indeed, the entire parapet and cap, are similar to that described on the N. Market Street facade.

To the north of the front on Market Street, an addition is in the process of being constructed. This will be a plain structure not matching the style of the old building, unfortunately, but the materials for the addition will match the off-white brick and light gray stone of the present bank.
